# REAL ESTATE/COMMISSION: Authorizes the La. Real Estate Commission to conduct criminal background checks

1	AN ACT
2	To amend and reenact R.S. 37:1437(B), (C), (D), and (E) and to enact R.S. 37:1437(F), (G),
3	(H), and (I), relative to licensing requirements for real estate brokers and
4	salespersons; to authorize the Louisiana Real Estate Commission to conduct a
5	criminal history background check on applicants for licensure; and to provide for
6	related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 37:1437(B), (C), (D), and (E) are hereby amended and reenacted and
9	R.S. 37:1437(F), (G), (H), and (I) are hereby enacted to read as follows:

1	C. In accordance with the provisions and procedures prescribed by this
2	Section, the commission may request and obtain state and national criminal history
3	record information from the Louisiana State Police Bureau of Identification and
4	Information and the Federal Bureau of Investigation relative to any applicant for
5	licensing whose fingerprints the commission has obtained, pursuant to this Section,
6	for the purpose of determining the applicant's suitability and eligibility for licensing.
7	D. Upon request by the commission and upon the commission's electronic
8	submission of an applicant's fingerprints, and such other identifying information as
9	may be required, the Louisiana State Police Bureau of Identification and Information
10	shall conduct a search of its criminal history record information relative to the
11	applicant and report the results of its search to the commission. The bureau may
12	charge the commission a processing fee pursuant to R.S. 15:587 for conducting and
13	reporting on any such search.
14	E. Any and all state or national criminal history record information obtained
15	by the commission from the Louisiana State Police Bureau of Identification and
16	Information or the Federal Bureau of Investigation, which is not already a matter of
17	public record, shall be deemed nonpublic and confidential information restricted to
18	the exclusive use of the commission, its members, officers, investigators, agents, and
19	attorneys in evaluating the applicant's eligibility or disqualification for licensing. No
20	such information or records related thereto shall be released or otherwise disclosed
21	by the commission or any other person or agency, except with the written consent
22	of the applicant or by order of a court of competent jurisdiction.
23	<u>F.(1)</u> Licenses shall be granted only to persons or entities who bear a good
24	reputation for honesty, trustworthiness, integrity, and competence to transact real
25	estate activities requiring licensing in this state in such a manner as to safeguard the
26	interest of the public, and only after satisfactory proof of such qualifications has been
27	presented to the commission.
28	(2) When an applicant has been convicted of forgery, embezzlement,
29	obtaining money under false pretenses, larceny, extortion, conspiracy to defraud, or

- theft, or has been convicted of a felony or a crime involving moral turpitude in any court of competent jurisdiction, such untrustworthiness of the applicant, and the conviction, may in itself be sufficient grounds for refusal of a license. (3) When an applicant has made a false statement of material fact on his application, such false statement may in itself be sufficient grounds for refusal of a license. (4) Grounds for suspension or revocation of a real estate license in Louisiana or any other jurisdiction, or the previous suspension or revocation, of a real estate license in Louisiana or any other jurisdiction shall also be grounds for refusal to grant a license.  $\underline{C}$ .  $\underline{G}$ .(1) No individual real estate broker or salesperson's license shall be issued to any person who has not attained the age of eighteen years. No individual real estate broker or salesperson's license shall be issued to any person who is not a high school graduate or the holder of a certificate of high school equivalency. (2)(a) All applicants for an initial individual real estate broker's license shall have first served actively for four years as a real estate salesperson and shall show evidence satisfactory to the commission that they have satisfactorily completed at least one hundred fifty hours or its equivalent of instruction in real estate courses approved by the commission prior to licensure. Satisfactory completion includes
- (b) At least thirty hours of the broker educational requirement shall be
  obtained in coursework emphasizing broker responsibilities.

passage of an examination on course contents.

(c) Each person obtaining an initial real estate broker's license shall complete
forty-five post-license education hours within one hundred eighty days after the
initial license date. Such hours shall be in subjects required by the commission,
including but not limited to laws, rules and regulations changes, finance, and the
handling of funds. Post-license education hours may be used to satisfy eight hours
of the twelve-hour annual continuing education requirement; however, post-license

education hours shall not satisfy the four-hour mandatory continuing education topic specified by the commission.

3 (3) The commission, through its education division, may accept real estate
4 related credit hours from an accredited college or university as partial substitution
5 of the broker licensing educational requirement.

6 (4) The commission shall have the authority to accept experience in the real 7 estate business or related fields as credit toward fulfillment of the education 8 requirements set forth herein.

9 (5)(a) All applicants for a salesperson's license shall show evidence 10 satisfactory to the commission that they have completed ninety hours or its 11 equivalent of instruction in real estate coursework approved by the commission prior 12 to licensure. Satisfactory completion includes passage of an examination on course 13 contents.

14 (b) Each person obtaining an initial salesperson's license shall complete 15 forty-five post-license education hours within one hundred eighty days after the 16 initial license date. Such hours shall be in subjects required by the commission, 17 including but not limited to laws, rules and regulations changes, finance, and the 18 handling of funds. Post-license education hours may be used to satisfy eight hours 19 of the twelve-hour annual continuing education requirement; however, post-license 20 education hours shall not satisfy the four-hour mandatory continuing education topic 21 specified by the commission.

22 (6)(a)(I) In addition to all other education requirements set forth in this 23 Chapter, the license of an individual real estate broker or salesperson shall not be 24 renewed unless the broker or salesperson shall furnish proof of completion of twelve 25 hours per year of continuing education pertaining to matters, including but not 26 limited to laws, rules, and regulations relative to licensing, appraisal, finance, taxes, 27 zoning, environmental quality, and the United States Department of Housing and 28 Urban Development. Four of the required annual continuing education hours shall 29 be in subjects specified by the commission. Post-license education hours may be

used to satisfy eight hours of the twelve-hour annual continuing education
 requirement; however, post-license education hours shall not satisfy the four-hour
 mandatory continuing education topic specified by the commission.

4 (ii) The commission shall promulgate rules and regulations necessary to
5 implement the continuing education requirement and may mandate the completion
6 of courses in specific real estate-related subjects. Such rules and regulations may
7 require passage of an examination in order to satisfy the continuing education
8 requirement.

9 D: H. Every applicant for a license shall submit a sworn statement attesting
10 that he has knowledge of and understands the provisions of the Fair Housing Act of
11 1968 and the Louisiana Equal Housing Opportunity Act, and any amendments
12 thereto or any successor legislation subsequently following, and that he shall not
13 induce or attempt to induce any person to sell or rent any dwelling by representations
14 regarding the entry or prospective entry into an area, subdivision, or neighborhood
15 of a person or persons of a particular race, color, religion, or national origin.

16 E. I. A nonresident may obtain a broker's or salesperson's license and engage
17 in the real estate business in this state under conditions prescribed by the
18 commission.

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

Abstract: Authorizes a criminal background check on applicants for real estate broker or salesperson's licensure.

<u>Present law</u> provides licensing requirements for an applicant for a real estate broker or salesperson's license to be issued by the La. Real Estate Commission.

Proposed law retains present law.

<u>Proposed law</u> provides that the commission may also require an applicant to:

- (1) Submit a full set of fingerprints in a form and manner prescribed by the commission.
- (2) Permit the commission to request and obtain state and national criminal history record information on the applicant.
- (3) Submit such amount as may be incurred by the commission in requesting and obtaining state and national criminal history record information on the applicant, in addition to all other applicable fees and costs.

<u>Proposed law</u> authorizes the commission to request and obtain state and national criminal history record information from the La. State Police Bureau of Identification and Information and the F.B.I. relative to any applicant for licensing whose fingerprints the commission has obtained for the purpose of determining the applicant's suitability and eligibility for licensing.

<u>Proposed law</u> provides that upon request by the commission and upon the commission's electronic submission of an applicant's fingerprints, and such other identifying information as may be required, the La. State Police Bureau of Identification and Information shall conduct a search of its criminal history record information relative to the applicant and report the results of its search to the commission. The bureau may charge the commission a processing fee for conducting and reporting on any such search.

<u>Proposed law</u> provides that any criminal history record information obtained by the commission from the La. State Police Bureau of Identification and Information or F.B.I., which is not already a matter of public record, shall be deemed nonpublic and confidential information restricted to the exclusive use of the commission, its members, officers, investigators, agents, and attorneys in evaluating the applicant's eligibility or disqualification for licensing. No such information or records related thereto shall be released or otherwise disclosed by the commission or any other person or agency, except with the written consent of the applicant or by order of a court of competent jurisdiction.
