AN ACT

2	To amend and reenact R.S. $40:13/9.3(B)(2)$ and $(1)(1)$ and $(2)$ and to enact R.S. $14:95(M)$
3	and R.S. 40:1379.3.3, relative to the illegal carrying of weapons; to exempt certain
4	persons from the crime of illegal carrying of weapons; to provide relative to
5	concealed handgun permits; to provide relative to the authority of a person to carry
6	a concealed handgun without a permit; to provide relative to the completion of a
7	sixty-minute online concealed handgun education course in order to carry a
8	concealed handgun without a permit; to provide relative to a database of licensed
9	firearm and handgun instructors; to provide relative to blood alcohol readings; and
10	to provide for related matters.

16	handgun permit issued by the state of Louisiana pursuant to the provisions of this

18	provisions of this Subsection shall not affect the requirements of reciprocity as

21	I.(1) No individual to whom a concealed handgun permit is issued or a

25	substance, an otherwise lawful permit is considered automatically suspended and is
26	not valid. A permittee person shall be considered under the influence as evidenced
27	by a blood alcohol reading of .05 .08 percent or greater by weight of alcohol in the
28	blood, or when a blood test or urine test shows any confirmed presence of a
29	controlled dangerous substance as defined in R.S. 40:961 and 964.

(2) A permittee person armed with a handgun in accordance with this Section or a person carrying a weapon pursuant to R.S. 14:95(M) shall notify any police officer who approaches the permittee person in an official manner or with an identified official purpose that he has a weapon on his person, submit to a pat down, and allow the officer to temporarily disarm him. Whenever a law enforcement officer is made aware that an individual is carrying a concealed handgun and the law enforcement officer has reasonable grounds to believe that the individual is under the influence of either alcohol or a controlled dangerous substance, the law enforcement officer may take temporary possession of the handgun and request submission of the individual to a department certified chemical test for determination of the chemical status of the individual. Whenever a law enforcement officer is made aware that an individual is behaving in a criminally negligent manner as defined under the provisions of this Section, or is negligent in the carrying of a concealed handgun as provided for in R.S. 40:1382, the law enforcement officer may seize the handgun, until adjudication by a judge, if the individual is issued a summons or arrested under the provisions of R.S. 40:1382. Failure by the permittee person to comply with the provisions of this Paragraph shall result in a six-month automatic suspension of the permit. §1379.3.3. Louisiana permitless carry A. The Department of Public Safety and Corrections, office of state police shall provide a sixty-minute online concealed handgun education course at no cost to Louisiana residents. B. The concealed handgun education course shall cover the following topics: (1) Concealed handgun basics and nomenclature. (2) Firearm free zones.

(4) Interactions with law enforcement officers.

(3) Use of deadly force.

1 C. The sixty-minute concealed handgun education course provided by this 2 Section does not fulfill the requirements for obtaining a Concealed Handgun Permit 3 under R.S. 40:1379.3. 4 D. State police shall maintain an online database of all licensed handgun and 5 firearm instructors to allow the public to search for classes. 6 E. The Department of Public Safety and Corrections, office of state police 7 shall promulgate rules and regulations in accordance with the Administrative 8 Procedure Act to implement the provisions of this Section.

**Abstract:** Exempts certain persons from the crime of illegal carrying of weapons, removes the requirement that a La. resident possess a permit issued by the state of La. in order to carry a concealed handgun in the state of La., requires state police to provide a 60-minute course at no cost to La. residents, requires state police to maintain and make available to the public a database of all licensed firearm and handgun instructors.

<u>Present law</u> (R.S. 14:95) prohibits the carrying of a concealed firearm, provides for criminal penalties, and provides for certain exceptions to the offense.

<u>Proposed law</u> creates an exception to this prohibition for a person who is 21 years of age or older and who is not prohibited from possessing a firearm under any federal or state law.

<u>Present law</u> (R.S. 40:1379.3) provides that La. residents who meet certain eligibility requirements may apply for and be issued a concealed handgun permit authorizing the person to carry a concealed handgun on his person in the state of La.

<u>Present law</u> requires the person to possess a valid concealed handgun permit issued by the state of La. in order to carry a concealed handgun in the state of La.

<u>Proposed law</u> removes <u>present law</u> requirement that a resident of La. possess a permit issued by the state of La. in order to carry a concealed handgun in the state of La.

<u>Proposed law</u> provides that an individual who meets the qualifications of R.S. 14:95(M) shall not be required to possess a valid concealed handgun permit issued by the state of Louisiana.

<u>Proposed law</u> specifies that <u>proposed law</u> shall not affect <u>present law</u> reciprocity requirements.

<u>Present law</u> provides that no individual with a concealed handgun permit may carry and conceal while under the influence of alcohol or a controlled dangerous substance.

<u>Present law</u> further provides that a person with a concealed handgun permit shall notify the officer, when approached in an official manner or with an identified official purpose, that he has a weapon on his person, submit to a pat down, and allow the officer to temporarily disarm him.

<u>Proposed law</u> retains <u>present law</u> and includes individuals carrying a concealed handgun pursuant to <u>proposed law</u>.

<u>Proposed law</u> requires state police to provide a 60-minute online concealed handgun education course at no cost to Louisiana residents to include the following topics:

- (1) Concealed handgun basics and nomenclature.
- (2) Firearm free zones.
- (3) Use of deadly force.
- (4) Interactions with law enforcement officers.

<u>Proposed law</u> further requires state police to maintain a database of all licensed handgun and firearm instructors to be made available to the public.

(Amends R.S. 40:1379.3(B)(2) and (I)(1) and (2); Adds R.S. 14:95(M) and R.S. 40:1379.3.3)

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Administration of</u> Criminal Justice to the original bill:

- 1. Make technical changes to the citations.
- 2. Expand the list of provisions that prohibit a person from possessing a firearm.
- 3. Specify that a La. resident who meets <u>proposed law</u> qualifications shall not be required to possess a permit and further specify that <u>proposed law</u> provisions shall not affect <u>present law</u> reciprocity requirements.
- 4. Specify that no individual carrying a concealed handgun pursuant to <u>proposed</u> <u>law</u> may carry while under the influence of alcohol or a controlled dangerous substance.
- 5. Specify that a person carrying a concealed handgun pursuant to <u>proposed law</u> shall notify the police officer that he has a weapon on his person, shall submit to a pat down, and shall allow the officer to temporarily disarm him.
- 6. Require state police to provide a 60-minute online concealed handgun education course.
- 7. Require state police to maintain a database of all licensed handgun and firearm instructors to be made available to the public.
