AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2011-3 2012 to be used to pay the consent judgment in the suit entitled "Kevin R. Johnson, 4 et al v. Lafay Flournoy, et al"; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. The sum of One Hundred Fifty Thousand and No/100 (\$150,000.00) 7 Dollars to be apportioned as follows: Forty-Two Thousand Eight Hundred Fifty-Seven and 8 14/100 (\$42,857.14) Dollars to Kevin R. Johnson, Guardian of the minor children Kevin P. 9 Johnson and Kolby K. Johnson; Twenty-One Thousand Four Hundred Twenty-Eight and 10 57/100 (\$21,428.57) Dollars to Dawn Patricia Fleming, Guardian of the minor child Justice 11 L. White; Twenty-One Thousand Four Hundred Twenty-Eight and 57/100 (\$21,428.57) 12 Dollars to Lawrence Smith, Guardian of the minor child Marneria D. White; Forty-Two 13 Thousand Eight Hundred Fifty-Seven and 14/100 (\$42,857.14) Dollars to Roderick King, Individually and on behalf of the Estate of Tabitha Shepherd King; and Twenty-One 14 15 Thousand Four Hundred Twenty-Eight and 57/100 (\$21,428.57) Dollars to Jeffrey Blanton 16 and Cynthia Gaylor, Co-Guardians of the minor child Jakeria Blanton; is hereby 17 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2011-2012 to 18 be used to pay the consent judgment in the suit entitled "Kevin R. Johnson, et al v. Lafay 19 Flournoy, et al", bearing Number 38,442 "B" on the docket of the Seventh Judicial District 20 Court, parish of Concordia, state of Louisiana.
