MTR VEHICLE/LICEN PLATES: Creates military honor specialty license plates

AN ACT

2	To enact R.S. 47:490.34 through 490.36, relative to military honor license plates; to provide
3	for the establishment of a military honor license plate for women veterans,
4	Commemorative Service recipients, and Military Medal Award recipients; to provide
5	for the creation, issuance, fees, distribution, and rule promulgation applicable to the
6	design of such plates; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 47:490.34 through 490.36 are hereby enacted to read as follows:
9	§490.34. Military honor license plates; "Woman Veteran"; "Commemorative
10	Service"; and "Military Medal Award"
11	A. The secretary of the Department of Public Safety and Corrections shall
12	establish a military honor license plate to be known as the "Woman Veteran" plate.
13	B. Upon application of a "Woman Veteran" recipient, the secretary of the
14	Department of Public Safety and Corrections shall issue a military honor license
15	plate to be used in lieu of a regular motor vehicle registration plate. The license plate
16	shall be restricted to use on passenger cars, pickup trucks, recreational vehicles,
17	motorcycles, and vans. The "Woman Veteran" plate shall include a U.S. flag
18	background, the seal of the veteran's branch of service, and the words "Woman
19	Veteran".

1	C. The charge for the license plate shall be the standard motor vehicle
2	license tax imposed by Article VII, Section 5 of the Constitution of Louisiana as
3	provided in R.S. 47:463, and a handling fee of three dollars and fifty cents for each
4	plate to be retained by the department to offset a portion of administrative costs.
5	D. The secretary shall adopt rules and regulations to implement the
6	provisions of this Section, including but not limited to rules governing the transfer
7	of license plates from one vehicle to another and the disposition of such license
8	plates.
9	E.(1) Any applicant who qualifies for the military honor license plate
10	authorized by this Section may be issued a license plate for each vehicle registered
11	in the applicant's name.
12	(2) Except as otherwise provided in this Paragraph, each military honor
13	license plate issued pursuant to this Section shall be returned to the secretary upon
14	the death of the person to whom the license plate was issued. The surviving spouse
15	of a person to whom a license plate was issued pursuant to this Section may retain
16	a license plate issued pursuant to this Section, provided the surviving spouse has not
17	remarried and provided the surviving spouse applies to the secretary for a transfer
18	of the license plate to the surviving spouse. A military honor license plate
19	transferred pursuant to this Paragraph to a surviving spouse shall be returned to the
20	secretary upon the death or remarriage of the surviving spouse.

22	A.(1) The secretary of the Department of Public Safety and Corrections shall
23	establish a military honor license plate to be known as the "Commemorative Service"

25	(2) This plate shall be made available to honorably discharged veterans who
26	served in the following conflicts:
27	(a) Global War on Terrorism.
28	(b) War in Iraq.
29	(c) War in Afghanistan.

Abstract: Creates the "Woman Veteran", "Commemorative Service" recipient, and "Military Medal Award" recipients speciality license plates.

Proposed law creates the "Woman Veteran", "Commemorative Service recipient", and "Military Medal Award". Provides for the use, name, fee, design, and specifications of the specialty plates.

Proposed law requires the "Woman Veteran" plate include a U.S. flag background, the seal of the veteran's branch of service, and the words "Woman Veteran".

CODING: Words in struck through type are deletions from existing law; words underscored are additions.

<u>Proposed law</u> requires the "Commemorative Service" be made available to honorably discharged veterans for serving in the following conflicts:

- (1) Global War on Terrorism.
- (2) War in Iraq.
- (3) War in Afghanistan.

<u>Proposed law</u> requires the "Commemorative Service" plate include a U.S. flag background, the seal of the veteran's branch of service, the name of the conflict, and the campaign ribbon.

<u>Proposed law</u> requires the "Military Medal Award" be made available to honorably discharged recipients, as certified by the Department of Veteran's Affairs, of the following medal awards:

- (1) Navy Cross.
- (2) Air Force Cross.
- (3) Defense Distinguished Service Medal.
- (4) Homeland Security Distinguished Service Medal.
- (5) Distinguished Service Medal (Army).
- (6) Navy Distinguished Service Medal.
- (7) Air Force Distinguished Service Medal.
- (8) Coast Guard Distinguished Service Medal.
- (9) Silver Star.
- (10) Defense Superior Service Medal.
- (11) Legion of Merit.
- (12) Distinguished Flying Cross.
- (13) Air Medal.
- (14) Soldier's Medal.

<u>Proposed law</u> requires the "Military Medal Award" plate include the U.S. flag background, the name of the veteran's branch of service, and the name and image of the medal.

<u>Proposed law</u> requires the secretary of the Dept. of Public Safety and Corrections to adopt rules relative to the implementation of the military honor license plates, including the transfer of the license plate to the surviving spouse and the disposition of the military honor license plates.

<u>Proposed law</u> requires the office of motor vehicles to create the military honor plates provided for in <u>proposed law</u> when the applicable statutory provisions are met and its system is updated to accommodate new plates.
