LEGISLATIVE COMMITTEES: Creates a legislative oversight committee to oversee and set priorities for the expenditure of federal monies received by the state for emergencies and disaster recovery

AN ACT

2	To enact Part V of Chapter 2 of Title 24 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 24:141, relative to legislative oversight; to create the Joint
4	Recovery Oversight Committee; to provide for its membership, powers, duties, and
5	functions; to require reports by the commissioner of administration and the director
6	of the Governor's Office of Homeland Security and Emergency Preparedness to the
7	joint committee; to provide for related functions and duties of the Joint Legislative
8	Committee on the Budget; to provide for an effective date; and to provide for related
9	matters.
10	Be it enacted by the Legislature of Louisiana:
11	Section 1. Part V of Chapter 2 of Title 24 of the Louisiana Revised Statutes of 1950,
12	comprised of R.S. 24:141, is hereby enacted to read as follows:
13	PART V. JOINT RECOVERY OVERSIGHT COMMITTEE
14	§141. Joint Recovery Oversight Committee; membership; powers, functions, duties
15	A.(1) The Joint Recovery Oversight Committee, referred to in this Part as
16	the "joint committee", is hereby created and shall consist of the following members
17	of the House of Representatives and of the Senate:
18	(a) Eight members of the House of Representatives appointed by the speaker
19	of the House of Representatives in a manner to reflect the makeup of the membership

1	of the House of Representatives, including party affiliation, race, sex, and geography,
2	to the extent practicable.
3	(b) Eight members of the Senate appointed by the president of the Senate in
4	a manner to reflect the makeup of the membership of the Senate, including party
5	affiliation, race, sex, and geography, to the extent practicable.
6	(2) The joint committee shall select a chairman and a vice chairman from
7	among its members. The position of chairman and vice chairman for the joint
8	committee shall rotate in even-numbered years on the second Monday in January
9	between the members of the House of Representatives and the members of the
10	Senate who serve on the committee.
11	B.(1) The joint committee shall monitor, review, and make recommendations
12	relative to all aspects of the expenditure of any federal monies received by the state
13	to assist in the recovery from any declared disaster or emergency in the manner
14	provided in this Section.
15	(2) The joint committee shall:
16	(a) Establish short-term priorities for recovery.
17	(b) Develop long-term plans and priorities for recovery and redevelopment.
18	(c) Recommend priorities and guidelines for funding that is provided or
19	otherwise made available to the state for recovery and redevelopment efforts and
20	infrastructure, including but not limited to:
21	(i) Economic and workforce development.
22	(ii) Education.
23	(iii) Healthcare.
24	(iv) Housing.
25	(v) Infrastructure and transportation.
26	(vi) Fiscal stability.
27	C. Each quarter, the joint committee shall submit a written comprehensive
28	report to each member of the legislature, the governor, the Governor's Office of
29	Homeland Security and Emergency Preparedness, the division of administration, and
30	the public regarding its activities, priorities, and other recommendations.

1	D.(1) To the fullest extent possible, all expenditures of federal monies
2	received by the state to assist in the recovery from any declared disaster or
3	emergency shall be made in accordance with the priorities for recovery established
4	by the joint committee.
5	(2) Each quarter in the manner determined by the joint committee, the
6	commissioner of the division of administration and the director of the Governor's
7	Office of Homeland Security and Emergency Preparedness shall provide the joint
8	committee with a recapitulation of all expenditures of federal monies received by the
9	state to assist in the recovery from any declared disaster or emergency for the
10	preceding three-month period.
11	(3) If the joint committee finds that the monies have not been expended in
12	accordance with the priorities established by the joint committee, the joint committee
13	shall immediately notify the governor, the Governor's Office of Homeland Security
14	and Emergency Preparedness, the division of administration, and the Joint
15	Legislative Committee on the Budget.
16	(4) If the Joint Legislative Committee on the Budget receives a notification
17	pursuant to Paragraph (3) of this Subsection, the Joint Legislative Committee on the
18	Budget shall meet to consider the information and shall consider the appropriate
19	action to take against the expending agency, which may include the withdrawal of
20	any approval to expend further funds, the limitation of the ability to expend further
21	funds, a limitation on the ability to transfer funds, or other appropriate sanction.
22	E. The joint committee may call upon the staffs of any department, agency,
23	or official of the state for data and assistance, and all departments, agencies, and
24	officials shall cooperate with the joint committee. The joint committee may request
25	and utilize the assistance of any and all private sources.
26	F. The joint committee shall have the power and authority to hold hearings,
27	compel the attendance and testimony of witnesses, require the production of books
28	and records, and do all other things necessary to discharge its duties.
29	G. The staff of the House Committee on Appropriations, the Senate
30	Committee on Finance, the legislative fiscal office, the legislative auditor, and any

1 other staff designated by the presiding officers shall provide staff support to the joint 2 committee. 3 Section 2.(A) The speaker of the House of Representatives and the president of the 4 Senate shall appoint the members of the joint committee established by this Act no later 5 than thirty days after the effective date of this Act. 6 (B) A member of the joint committee designated by the speaker of the House of Representatives shall call the first meeting of the joint committee established by this Act no 7 8 later than ten days after all of the members are appointed and shall preside until the joint 9 committee selects a chairman and a vice chairman in the manner provided in this Act. 10 Section 3. This Act shall become effective upon signature by the governor or, if not 11 signed by the governor, upon expiration of the time for bills to become law without signature 12 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 13 vetoed by the governor and subsequently approved by the legislature, this Act shall become

**Abstract:** Establishes the Joint Recovery Oversight Committee to set priorities for and oversee the expenditure of federal monies received by the state for disaster and emergency recovery.

<u>Proposed law</u> provides for the Joint Recovery Oversight Committee, (joint committee) as follows:

- (1) Consists of 16 members, eight members of the House appointed by the speaker and eight members of the Senate appointed by the president, all appointed to reflect the makeup of the membership of the respective house of the legislature, including party affiliation, race, sex, and geography, to the extent practicable.
- (2) Provides that the joint committee shall select a chairman and a vice chairman from among its members and that those positions rotate in even-numbered years on the second Mon. in Jan. between the members of the House and the members of the Senate who serve on the committee.

<u>Proposed law</u> provides that powers, functions, and duties of the joint committee include to:

(1) Monitor, review, and make recommendations relative to all aspects of the expenditure of any federal monies received by the state to assist in the recovery from any declared disaster or emergency.

(2) Establish short-term priorities for recovery, develop long-term plans, and priorities for recovery and redevelopment, and recommend priorities and guidelines for funding made available to the state for recovery and redevelopment efforts and infrastructure.

(3) Submit a comprehensive report to the legislature, the governor, Governor's Office of Homeland Security and Emergency Preparedness (GOHSEP), the division of administration, and the public each quarter.

<u>Proposed law</u> requires that, to the fullest extent possible, all expenditures of federal monies received by the state to assist in the recovery from any declared disaster or emergency shall be made in accordance with the priorities for recovery established by the joint committee. Requires, each quarter, the commissioner of administration and the director of the GOHSEP to provide the joint committee with a recapitulation of all expenditures of federal monies received by the state to assist in the recovery from any declared disaster or emergency for the preceding three-month period. Requires the joint committee to notify the governor, GOHSEP, the division of administration, and the Joint Legislative Committee on the Budget (JLCB) if it finds that monies have not been expended in accordance with its priorities. Requires JLCB to meet and consider the appropriate action to take against the expending agency, which may include the withdrawal of any approval to expend further funds, the limitation of the ability to expend further funds, a limitation on the ability to transfer funds, or other appropriate sanction.

<u>Proposed law</u> provides for legislative staffing of the joint committee and provides that the joint committee may call upon the staffs of any department, agency, or official of the state for data and assistance, and all departments, agencies, and officials shall cooperate with the joint committee. The joint committee may request and utilize the assistance of any and all private sources. Specifies that it has the power and authority to hold hearings, compel the attendance and testimony of witnesses, require the production of books and records, and do all other things necessary to discharge its duties.

<u>Proposed law</u> provides for the appointment of members no later than 30 days after effective date of <u>proposed law</u> and provides for the calling of the first meeting no later than 10 days after the members are appointed.

Effective upon signature of governor or lapse of time for gubernatorial action.
