| 12 | Community of Resilience Fund as a special escrow fund in the state treasury; to |
| 13 | provide for the administration and use of monies in the funds; to authorize the |
| 14 | secretary of the Department of Revenue to make certain deposits into the funds; to |
| 15 | provide for reporting; to provide for an effective date; and to provide for related |
| 16 | matters. |

| 5 | §120.181. Income tax checkoff; Louisiana National Guard Honor Guard for |

| 7 | A. Every individual who files an individual income tax return for the current |
| 8 | tax year and who is entitled to a refund may designate on his current year return that |
| 9 | all or any portion of the total amount of the refund to which he is entitled shall be |
| 10 | donated to the Louisiana National Guard Honor Guard for Military Funerals, |
| 11 | hereinafter referred to as the "Honor Guard", in lieu of that amount being paid to him |
| 12 | as a refund. In this case the refund shall be reduced by the amount so designated. |
| 13 | The designation shall be made at the time of filing the current year tax return and |
| 14 | shall be made upon the income tax return form as prescribed by the secretary of the |
| 15 | Department of Revenue, hereinafter referred to as the "secretary". No donation made |
| 16 | under the provisions of this Subpart shall be invalid for want of an authentic act. |
| 17 | B. There is hereby established in the state treasury a special escrow fund to |
| 18 | be known as the Honor Guard for Military Funerals Fund, hereinafter referred to as |
| 19 | the "fund". The fund is established to receive deposits of donations made on |
| 20 | individual income tax returns for the benefit of the Honor Guard. The fund shall be |
| 21 | administered by the state treasurer who shall, every three months, remit the |
| 22 | remaining balance of monies in the fund to the Department of Military Affairs to be |
| 23 | used for purposes of the Honor Guard. The department shall use the monies derived |
| 24 | from such donations for the purpose of providing military funeral honors for |
| 25 | members of Louisiana's military forces. |
| 26 | C. The House Committee on Ways and Means may, at its discretion, request |
| 27 | a report from the department relative to the operation of the Honor Guard. The form |
| 28 | and content of the report shall be prescribed by the chairman of the committee, but |
| 29 | shall at a minimum contain a detailed explanation of the revenues and expenditures. |
| 30 | as well as a description of the Honor Guard's activities. The committee may |

| 25 | a report from Bastion Community of Resilience relative to its operations. The form |
| 26 | and content of the report shall be prescribed by the chairman of the committee, but |
| 27 | shall at a minimum contain a detailed explanation of the revenues and expenditures, |
| 28 | as well as a description of Bastion Community of Resilience activities. The |
| 29 | committee may summon any person employed by or associated with Bastion |
| 30 | Community of Resilience to provide testimony with respect to the report. |
