APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against the state in the matter of "Mark and Michelle Gagnard, et al v. Kansas City Southern Railway, et al"

AN ACT

2	To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2011-
3	2012 to be used to pay the consent judgment against the state in the suit entitled
4	"Mark and Michelle Gagnard individually and on behalf of their minor child, Kelsie
5	Gagnard v. Kansas City Southern Railway Company, Chrysler Corporation, Deanna
6	Gaspard and Financial Indemnity Company"; to provide for court costs; and to
7	provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. The sum of Five Thousand and No/100 (\$5,000.00) Dollars, plus court
10	costs in the amount of Five Hundred Fifty-Six and 80/100 (\$556.80) Dollars, is hereby
11	appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2011-2012 to
12	be used to pay the consent judgment against the state in the suit entitled "Mark and Michelle
13	Gagnard individually and on behalf of their minor child, Kelsie Gagnard v. Kansas City
14	Southern Railway Company, Chrysler Corporation, Deanna Gaspard and Financial
15	Indemnity Company", bearing Number 2009-3059, Division A, on the docket of the Twelfth
16	Judicial District Court, parish of Avoyelles, state of Louisiana.
17	Section 2. This Act shall become effective on July 1, 2011; if vetoed by the governor
18	and subsequently approved by the legislature, this Act shall become effective on July 1,
19	2011, or on the day following such approval by the legislature, whichever is later.
