Abstract: Requires nonpublic schools participating in the Student Scholarships for Educational Excellence Program and the School Choice Pilot Program for Certain Students with Exceptionalities (voucher programs) to ensure that all school accountability program tests are administered to all students attending the schools.

<u>Present law</u> (Student Scholarships for Educational Excellence Program) provides for a school choice program for eligible k-6 students. Provides that eligible students shall be those in Orleans Parish from families with a total income not exceeding 250% of the current federal poverty guidelines. Provides for scholarships to be awarded to eligible students to attend public and nonpublic schools in Orleans Parish that volunteer to participate in the program and meet certain eligibility requirements. Requires participating nonpublic schools to ensure that scholarship recipients are administered all examinations required pursuant to the state's school and district accountability program.

<u>Present law</u> (School Choice Pilot Program for Certain Students with Exceptionalities) provides for a two-year pilot program in parishes with a population in excess of 190,000 (currently, Caddo, Calcasieu, East Baton Rouge, Jefferson, Lafayette, Orleans, and St. Tammany). Provides for student eligibility including that the student is determined to be in need of special education services for specified exceptionalities, is residing within a pilot program parish, and is entering kindergarten or grades one through eight. Provides for nonpublic school eligibility, requirements, and authority. Permits parents/guardians of eligible students to apply for educational certificates for the cost of educational services offered by eligible nonpublic schools.

<u>Proposed law</u> retains <u>present law</u> and adds that nonpublic schools participating in both programs shall ensure that all students enrolled in the schools are administered all examinations required pursuant to the school and district accountability system at the prescribed grade levels.
