2 To amend and reenact R.S. 40:1505(D), relative to parcel fees levied by fire protection 3 districts in Lafourche Parish; to provide a definition of parcel; to provide for 4 responsibility for the parcel fee; and to provide for related matters. 5 Notice of intention to introduce this Act has been published as provided by Article III, Section 13 of the Constitution of 6 7 Louisiana. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. R.S. 40:1505(D) is hereby amended and reenacted to read as follows: 10 §1505. Parcel fee; submission to voters 11 12 D.(1) A "parcel" as used in this Section shall mean a lot, a subdivided 13 portion of ground or an individual tract upon which is located, either in whole or in 14 part, a residential or commercial structure, regardless of the structure's being 15 occupied or unoccupied. 16 (2)(a) Notwithstanding the provisions of Paragraph (1) of this Subsection, 17 within Fire Protection District 8-C in Lafourche Parish the term parcel shall mean 18 each improved portion of ground upon which a residential or commercial structure has been or may be situated and to which a mailing address has been assigned by a 19 20 local governmental subdivision, a landowner, or a lessor.

(b) In the case of trailer parks or other commercial lots which lease spaces
for residential structures, the parcel fee for each portion of ground described in

Abstract: Provides a definition of "parcel" for the levy of a parcel fee within Fire Protection District 8-C in Lafourche Parish

<u>Present law</u> provides for the creation of fire protection districts. Provides for their powers and duties and authorizes the levy of certain taxes or fees to support each district.

<u>Present law</u> provides for the levy of a parcel fee, not to exceed \$100, within each district. <u>Present law</u> further defines "parcel" for purposes of the fire protection district parcel fee to mean a lot or portion of ground upon which a residential or commercial structure is located, regardless of whether or not such structure is occupied.

Proposed law retains present law.

<u>Proposed law</u> creates a special definition of "parcel" for Fire Protection District 8-C in Lafourche Parish. Under <u>proposed law</u>, "parcel" means each improved portion of ground upon which a residential or commercial structure has been or may be situated and to which a mailing address has been assigned by a parish or a municipality, a landowner, or a lessor. <u>Proposed law</u> further provides that in the case of a trailer park or other commercial lots which lease space for residential structures, the parcel fee described in <u>proposed law</u> shall be the responsibility of the landowner.
