The commissioner of administration, on behalf of the state of Louisiana, 22 and the Grand Isle Port Commission are hereby authorized to enter into such agreements, 23 covenants, conditions, and stipulations and to execute such documents as necessary to 24 properly effectuate the use of property described in Section 1 of this Act, and as more 25 specifically described in any such agreements entered into and documents executed by and 26 between the state and the port commission. In determining appropriate compensation for 27 the use of state property authorized by this Act, the commissioner may consider potential

economic development and other benefits resulting from the research contemplated.
