### 1 AN ACT 2 To enact R.S. 33:9097.25, relative to East Baton Rouge Parish, to create the Riverbend 3 Crime Prevention and Improvement District; to provide relative to the boundaries, 4 purpose, governance, and powers and duties of the district; to provide relative to 5 district funding, including the authority to impose a parcel fee within the district; and 6 to provide for related matters. 7 Notice of intention to introduce this Act has been published 8 as provided by Article III, Section 13 of the Constitution of 9 Louisiana. 10 Be it enacted by the Legislature of Louisiana: 11 Section 1. R.S. 33:9097.25 is hereby enacted to read as follows: 12 §9097.25. Riverbend Crime Prevention and Improvement District 13 A. Creation. There is hereby created within the parish of East Baton Rouge, 14 as more specifically provided in Subsection B of this Section, a body politic and 15 corporate which shall be known as the Riverbend Crime Prevention and 16 Improvement District, hereinafter referred to as the "district". The district shall be 17 a political subdivision of the state as defined in the Constitution of Louisiana. 18 B. Boundaries. The district shall include all property shown on the final 19 subdivision plats for Riverbend Subdivision filings First, Second, Third, Fourth, 20 Fifth, Eighth, and Ninth filed with the East Baton Rouge Parish Clerk of Court. 21 C. Purpose. The purpose of the district shall be to aid in crime prevention 22 and to add to the security of district residents by providing for an increase in the 23 presence of law enforcement personnel in the district and to serve the needs of the

1	residents of the district by funding beautification and improvements for the overall
2	betterment of the district.
3	D. Governance. (1) The district shall be governed by a seven-member board
4	of commissioners, referred to in this Section as the "board". The board shall be
5	composed as follows:
6	(a) The president of the Riverbend Homeowners Association, referred to in
7	this Section as the "association".
8	(b) The board of directors of the association shall appoint three members.
9	(c) The member of the Louisiana House of Representatives whose district
10	encompasses all or the greater portion of the area of the district shall appoint one
11	member.
12	(d) The member of the Louisiana Senate whose district encompasses all or
13	the greater portion of the area of the district shall appoint one member.
14	(e) The assessor for the parish of East Baton Rouge shall appoint one

1	(5) The minute books and archives of the district shall be maintained by the
2	secretary of the board. The monies, funds, and accounts of the district shall be in the
3	official custody of the board.
4	(6) The board shall adopt such by laws as it deems necessary or advisable for
5	conducting its business affairs. Rules and regulations of the board relative to the
6	notice and conduct of meetings shall conform to applicable law, including, if
7	applicable, the Open Meetings Law. The board shall hold regular meetings as shall
8	be provided for in the bylaws and may hold special meetings at such times and
9	places within the district as may be prescribed in the bylaws.
10	(7) A majority of the members of the board shall constitute a quorum for the
11	transaction of business. The board shall keep minutes of all meetings and shall make
12	them available through the secretary of the board.
13	(8) Each member of the board shall have one vote, and the vote of a majority
14	of the members of the board present and voting, a quorum being present, shall be
15	required to decide on any question upon which the board takes action.
16	(9) The members of the board shall serve without compensation but shall be
17	reimbursed for their reasonable out-of-pocket expenses directly related to the
18	governance of the district.
19	E. Powers and duties. The district, acting through its board, shall have the
20	following powers and duties:
21	(1) To sue and be sued.
22	(2) To adopt, use, and alter at will a corporate seal.
23	(3) To receive and expend funds collected pursuant to Subsection F of this
24	Section and in accordance with a budget adopted as provided by Subsection H of this
25	Section.
26	(4) To enter into contracts with individuals or entities, private or public.
27	(5) To provide or enhance security patrols in the district, to provide for
28	improved lighting, signage, or matters relating to the security of the district, to
29	provide for the beautification of and improvements for the district, or to provide
30	generally for the overall betterment of the district.

1	F. Parcel fee. The district may impose and collect a parcel fee within the
2	district subject to and in accordance with the provisions of this Subsection.
3	(1)(a) The fee shall be imposed on each improved and unimproved parcel
4	located within the district. The owner of the parcel shall be responsible for payment
5	of the fee.
6	(b) For purposes of this Section, a parcel shall be defined as a lot, a
7	subdivided portion of ground, or an individual tract which is zoned residential;
8	however, the term "parcel" shall not include "condominium parcel" or
9	"condominium property" as defined in R.S. 9:1121.103.
10	(2)(a) The initial amount of the fee shall be as provided in a duly adopted
11	resolution of the governing authority of the district. The initial fee shall not exceed
12	one hundred fifty dollars per parcel per year.
13	(b) The fee shall be imposed only after the question of its imposition has
14	been approved by a majority of the registered voters of the district voting on the
15	proposition at an election held for that purpose in accordance with the Louisiana
16	Election Code.
17	(3) Not less than three years after approval of the parcel fee by a majority of $\frac{1}{2}$
18	registered voters of the district as provided in this Subsection, the governing
19	authority of the district may increase the amount of the parcel fee one time without
20	an election. The amount of the increased fee shall be as provided in a duly adopted
21	resolution of the board, not to exceed two hundred fifty dollars per parcel per year.
22	(4) A parcel fee shall expire fifteen years after its levy but may be renewed
23	if the renewal is approved by the voters in the manner provided in Subparagraph
24	(2)(b) of this Subsection. The renewed fee shall not exceed two hundred fifty dollars
25	per parcel per year. If renewed, the term of the imposition of the fee shall be as
26	provided in the proposition authorizing such renewal, not to exceed fifteen years.
27	(5) The fee shall be collected at the same time and in the same manner as ad
28	valorem taxes are collected by the sheriff, as ex officio tax collector, of the parish of
29	East Baton Rouge. The sheriff shall collect and remit to the district all amounts

1	collected. The district may enter into an agreement with the sheriff to authorize the
2	sheriff to retain a collection fee not to exceed one percent of the amount collected.
3	(6) Any parcel fee which is unpaid shall be added to the tax rolls of East
4	Baton Rouge Parish and shall be enforced with the same authority and subject to the
5	same penalties and procedures as unpaid ad valorem taxes.
6	G. Additional contributions. The district is authorized to solicit and accept
7	additional voluntary contributions and grants to further the purposes of the district.
8	H. Budget. (1) The board of commissioners shall adopt an annual budget
9	in accordance with the Louisiana Local Government Budget Act, R.S. 39:1301 et
10	<u>seq.</u>
11	(2) The district shall be subject to audit by the legislative auditor pursuant
12	to R.S. 24:513.
13	I. Miscellaneous provisions. (1) It is the purpose and intent of this Section
14	that the additional law enforcement personnel and their services provided for through
15	the fees authorized in this Section shall be supplemental to and not in lieu of
16	personnel and services provided in the district by the city of Baton Rouge, parish of
17	East Baton Rouge.
18	(2) If the district ceases to exist, any funds of the district shall be transmitted
19	to the governing authority of the city Baton Rouge, parish of East Baton Rouge and
20	shall be used for law enforcement purposes in the area which comprised the district.
21	J. Indemnification and exculpation. (1) The district shall indemnify its
22	officers and board members to the fullest extent permitted by R.S. 12:227, as fully
23	as if the district were a nonprofit corporation governed thereby, and as may be
24	provided in the district's bylaws.
25	(2) No board member or officer of the district shall be liable to the district
26	or to any individual who resides, owns property, visits, or otherwise conducts
27	business in the district for monetary damages for breach of his duties as a board
28	member or officer, provided that this provision shall not eliminate or limit the
29	liability of a board member or officer for any of the following:

1	(a) Acts or omissions not in good faith or which involve intentional
2	misconduct or a knowing violation of law.
3	(b) Any transaction from which he derived an improper personal benefit.
4	(3) To the fullest extent permitted by R.S. 9:2792 et seq., including R.S.
5	9:2792.1 through 2792.9, a person serving the district as a board member or officer
6	shall not be individually liable for any act or omission arising out of the performance
7	of his duties.
8	Section 2. This Act shall become effective upon signature by the governor or, if not
9	signed by the governor, upon expiration of the time for bills to become law without signature
10	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
11	vetoed by the governor and subsequently approved by the legislature, this Act shall become
12	effective on the day following such approval.
