1 AN ACT 2 To amend and reenact R.S. 40:5.3.1, relative to oyster harvest and production; to require the 3 Department of Health and Hospitals to notify oyster harvesters and dealers of a 4 possible state exemption from the National Shellfish Sanitation Program's Vibrio 5 management plan; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 40:5.3.1 is hereby amended and reenacted to read as follows: 8 §5.3.1. Exemptions 9 The Department of Health and Hospitals, in consultation with the Department 10 of Wildlife and Fisheries, may annually grant an exemption from the National 11 Shellfish Sanitation Program's Vibrio parahaemolyticus and Vibrio vulnificus 12 management plans to licensed oyster harvesters and certified oyster dealers if the 13 licensed oyster harvester or the certified oyster dealer has not been epidemiologically 14 linked to a Vibrio parahaemolyticus or Vibrio vulnificus oyster-related oyster-related 15 illness. The Department of Health and Hospitals, office of public health, shall notify 16 all licensed oyster harvesters and certified dealers of the provisions of this Section 17 and notify such persons that they may apply to the Department of Health and

**Abstract:** Requires DHH to notify oyster harvesters and dealers of a possible state exemption from the National Shellfish Sanitation Program's *Vibrio* management plan.

<u>Present law</u> authorizes the office of public health to grant an exemption from the National Shellfish Sanitation Program's *Vibrio parahaemolyticus* and *Vibrio sulnificus* management plans to oyster harvesters and dealers that have not been epidemiologically linked to a V.p. or V.v. oyster-related illness.

<u>Proposed law</u> requires the office of public health, Dept. of Health and Hospitals, to notify oyster harvesters and dealers of such possible exemption.
