HOUSE BILL NO. 701

1 AN ACT

2 To amend and reenact R.S. 38:330.7, relative to police officers for the Southeast Louisiana
3 Flood Protection Authorities; to authorize the employment of a superintendent by the
4 Southeast Flood Protection Authority - East; to provide for such superintendent's
5 powers and authority; to authorize the use of police security personnel from one
6 levee district within another under certain circumstances; and to provide for related
7 matters.

8 Notice of intention to introduce this Act has been published
9 as provided by Article III, Section 13 of the Constitution of
10 Louisiana.

11 Be it enacted by the Legislature of Louisiana:

12 Section 1. R.S. 38:330.7 is hereby amended and reenacted to read as follows:

13 §330.7. Police officers

14 A. Each authority shall not directly employ police security personnel.
15 However, the authority may enter into cooperative endeavor agreements with
16 appropriate local law enforcement agencies or local governmental subdivisions to
17 provide necessary police security services for levees, or the authority may assume
18 the rights and responsibilities of any existing cooperative endeavor agreements for
19 police security services.

20 B. Notwithstanding the provisions of Subsection A of this Section, the
21 Southeast Louisiana Flood Protection Authority - East may employ a superintendent
22 of police security to supervise the police security personnel of all levee districts
23 within its territorial jurisdiction. The superintendent shall have authority and the
24 right to exercise the power of a police officer, including the power of arrest

1 throughout the territorial jurisdiction of the authority. The salary of the SLFPA-East
 2 superintendent of police security shall not exceed the salary of the superintendent of
 3 the Louisiana State Police. The authority may assess each levee district within its
 4 territorial jurisdiction an amount necessary for the salary, benefits, and expenses of
 5 the superintendent.

6 C. Notwithstanding the provisions of Subsection A of this Section and R.S.
 7 38:326, the Southeast Louisiana Flood Protection Authority - East, in the interest of
 8 public safety, may deploy police security personnel employed by one levee district
 9 within its territorial jurisdiction in another levee district within its territorial
 10 jurisdiction, provided that the levee district supplying the personnel is fully
 11 compensated for such deployment and the deployment does not create a public safety
 12 concern in any of the other districts. In the event full compensation for such
 13 deployments is not received, the delinquent district shall not be eligible for future
 14 deployments until making all necessary payments. Each police officer shall retain
 15 his powers when he is deployed outside his district of employment.
