PUBLIC CONTRACTS: Provides for a twice annual report to the Joint Legislative Committee on the Budget regarding contracts let in the construction of the University Medical Center in New Orleans

1 AN ACT

2 To enact R.S. 38:2225.1.1 relative to public contracts; to provide for a report on contracts  
3 let in the construction of University Medical Center in New Orleans; and to provide  
4 for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 38:2225.1.1 is hereby enacted to read as follows:

7 §2225.1.1. Reporting of contracts let in the construction of University Medical  
8 Center in New Orleans

9 The Louisiana State University Board of Supervisors and the University  
10 Medical Center Management Corporation shall report twice annually, once in  
11 September and once in February, to the Joint Legislative Committee on the Budget  
12 relative to the contracts let in the construction of the University Medical Center  
13 hospital in New Orleans. Such report shall include the following for new contracts  
14 let during the reporting period:

15 A. The total number of contracts let to all contractors.

16 B. The total value of contracts let to all contractors.

17 C. The total number of contracts let to local and disadvantaged business  
18 enterprises expressed as a percentage of the total number of contracts let.

1           D. The total value of contracts let to local and disadvantaged business  
2           enterprises expressed as a percentage of the total value of contracts let.

3           E. The total number of contracts let to a fifty-fifty joint venture enterprise  
4           expressed as a percentage of the total number of contracts let.

5           F. The total value of contracts let to a fifty-fifty joint venture enterprise  
6           expressed as a percentage of the total value of contracts.

7           G. The total number of subcontracts awarded to disadvantaged business  
8           enterprises which were awarded by contractors that are not disadvantaged business  
9           enterprises expressed as a percentage of the total number of contracts let.

10          H. The total value of subcontracts awarded to disadvantaged business  
11          enterprises which were awarded by contractors that are not disadvantaged business  
12          enterprises expressed as a percentage of the total value of contracts let.

13          I. Total number of disadvantaged business enterprises in which a contract  
14          was let or that was subcontracted expressed as a percentage of the total number of  
15          companies in which a contract was let or that was subcontracted.

**Abstract:** Requires reporting in September and February to the Joint Legislative Committee on the Budget regarding contracts let in the construction of the University Medical Center in New Orleans.

Proposed law provides that the Louisiana State University Board of Supervisors and the University Medical Center Management Corporation shall report twice annually, in September and February, to the Joint Legislative Committee on the Budget relative to the hiring of local and disadvantaged business enterprises when contracting relative to the construction of the University Medical Center hospital in New Orleans. Such report shall include the following for new contracts let during the reporting period:

- (1) The total number of contracts let to all contractors.
- (2) The total value of contracts let to all contractors.
- (3) The total number of contracts let to local and disadvantaged business enterprises expressed as a percentage of the total number of contracts let.

- (4) The total value of contracts let to local and disadvantaged business enterprises expressed as a percentage of the total value of contracts let.
- (5) The total number of contracts let to a fifty-fifty joint ventures enterprises expressed as a percentage of the total number of contracts let.
- (6) The total value of contracts let to a fifty-fifty joint ventures enterprises expressed as a percentage of the total value of contracts let expressed as a percentage.
- (7) The total number of subcontracts awarded to disadvantaged business enterprises which were awarded by contracts that are not disadvantaged business enterprises expressed as a percentage of the total number of contracts let.
- (8) The total value of subcontracts awarded to disadvantaged business enterprises which were awarded by contractors that are not disadvantaged business enterprises expressed as a percentage of the total value of contracts let.
- (9) Total number of disadvantaged business enterprises in which a contract was let or that was subcontracted expressed as a percentage of the total number of companies in which a contract was let or that was subcontracted.
