2	To enact R.S. 17:7(33), relative to the powers and duties of the State Board of Elementary

7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 17:7(33) is hereby enacted to read as follows:

10	In addition to the authorities granted by R.S. 17:6 and any powers, duties, and
11	responsibilities vested by any other applicable laws, the board shall:

13	(33) Develop, adopt, and provide for the implementation of a program for
14	grading parents and guardians on their participation in the successful education of
15	their children. The program shall provide for schools to evaluate parents on factors
16	including but not limited to:
17	(a) Assisting students with homework.

**Abstract:** Requires the State Board of Elementary and Secondary Education to develop, adopt, and provide for the implementation of a program for grading parents on their participation in the education of their children..

<u>Present law</u> provides for the powers and duties of the State Board of Elementary and Secondary Education (BESE). <u>Proposed law</u> adds to <u>present law</u> a requirement that BESE develop, adopt, and provide for the implementation of a program for grading parents on their participation in the education of their children. The program shall provide for schools to evaluate parents on factors including but not limited to:

- (1) Assisting students with homework.
- (2) Providing school materials to students.
- (3) Imposing of discipline on students.
- (4) Encouraging students to follow the dress code.
- (5) Participation in parent conferences and parent-teacher meetings.
- (6) Encouraging students to attend class regularly.
