MTR VEHICLE/LICEN PLATES: Creates the "En français S.V.P" specialty license plate

1	AN ACT	
2	To enact R.S. 47:463.209, relative to motor vehicle special prestige license plates; to	
3	establish the "En français S.V.P" specialty license plate; to provide for the creation,	
4	issuance, design, fees, implementation, distribution, and rule promulgation	
5	applicable to such license plate; and to provide for related matters.	
6	Be it enacted by the Legislature of Louisiana:	
7	Section 1. 47:463.209 is hereby enacted to read as follows:	
8	§463.209. Special prestige license plate; "En français S.V.P"	
9	A. The secretary of the Department of Public Safety and Corrections shall	
10	establish a special prestige motor vehicle license plate to be known as the "En	
11	français S.V.P" plate, provided there are a minimum of one thousand applicants for	
12	such plate. The plate shall be restricted to use on passenger cars, pickup trucks,	
13	recreational vehicles, motorcycles, and vans.	
14	B. The secretary shall work in conjunction with the Saint LUC French	
15	Immersion and Cultural Campus Board of Directors to select the color and design	
16	of the plate, provided the design is in compliance with R.S. 46:463(A)(3). The	
17	design shall include the phrase "Saint LUC. En français SVP " and shall also include	
18	<u>a prominent logo.</u>	
19	C. The special prestige license plate shall be issued, upon application, to any	
20	citizen of Louisiana in the same manner as any other motor vehicle license plate.

1	D. The department shall collect an annual royalty fee of twenty-five dollars		
2	that shall be disbursed in accordance with Subsection E of this Section. This fee		
3	shall be in addition to the standard motor vehicle license tax imposed by Article VII,		
4	Section 5 of the Constitution of Louisiana, and a handling fee of three dollars and		
5	fifty cents for each plate to be retained by the department to offset a portion of		
6	administrative costs.		
7	E. The annual royalty fee shall be collected by the department and disbursed		
8	solely to fund programming at the Saint LUC French Immersion and Cultural		
9	Campus.		
10	F. The secretary shall promulgate and adopt rules and regulations as are		
11	necessary to implement the provisions of this Section.		
12	Section 2. The Department of Public Safety and Corrections, office of motor		
13	vehicles, is hereby directed to create the special prestige license plate when the applicable		
14	statutory provisions are met and its system is updated to accommodate the creation of new		
15	plates.

Abstract: Creates the "En français S.V.P" special prestige license plate. Provides for the creation, issuance, design, implementation, fees, distribution, and promulgation of rules applicable to this license plate.

<u>Proposed law</u> requires the Dept. of Public Safety and Corrections to issue a special prestige license plate to be known as the "En français S.V.P" license plate, provided there is a minimum of 1,000 applicants for such plate.

<u>Proposed law</u> requires the secretary to work in conjunction with the Saint LUC French Immersion and Cultural Campus Board of Directors to select the color and design of the plate, provided the design is in compliance with R.S. 47:463(A)(3). The design shall include the phrase "Saint LUC. En français SVP " and shall also include a prominent logo. <u>Proposed law</u> specifies that the license plate be issued, upon application, to any citizen of La. in the same manner as any other motor vehicle license plate.

<u>Proposed law</u> requires the department to collect an annual royalty fee of \$25 in addition to the standard motor vehicle license tax and a \$3.50 handling fee for each plate to be retained by the department to offset a portion of administrative costs.

<u>Proposed law</u> requires monies received from the royalty fees be disbursed solely to fund programming at the Saint LUC French Immersion and Cultural Campus.

<u>Proposed law</u> requires the secretary to promulgate and adopt rules and regulations to implement the provisions provided in <u>proposed law</u>.

Directs the office of motor vehicles to create the "En français S.V.P" specialty license plate when the applicable statutory provisions are met and its system is updated to accommodate the creation of new plates.
