STATE OFFICIALS: Provides relative to mandatory annual mental health response training and individual counseling requirements for statewide elected officials and legislators

AN ACT

2 To enact Chapter 6 of Title 49 of the Louisiana Revised Statutes of 1950, comprised of R.S. 3 49:351 through 353, relative to certain state officials; to require certain state officials 4 to receive annual mental health response training; to require certain state officials to 5 receive a certain amount of professional mental health counseling each year; and to 6 provide for related matters. Be it enacted by the Legislature of Louisiana: 7 8 Section 1. Chapter 6 of Title 49 of the Louisiana Revised Statutes of 1950, 9 comprised of R.S. 49:351 through 353 is hereby enacted to read as follows: 10 CHAPTER 6. MENTAL HEALTH REQUIREMENTS 11 §351. Legislative findings 12 The legislature recognizes the impact that mental health issues, including 13 undiagnosed mental illness and related substance abuse has on all of our citizens, and 14 particularly our children, our economy, our education system, and our criminal 15 justice system. The legislature further recognizes that the state benefits when mental 16 health issues are diagnosed early and addressed with an appropriate treatment plan. 17 To be an example to all of the citizens of our state, the legislature enacts the 18 provisions of this Chapter in order for the leaders and policymakers of this state to 19 learn how to recognize mental health issues and how to direct our citizens to the 20 proper care, as well as to prioritize their own mental well-being by seeking and obtaining personal mental health counseling from a licensed professional. 21

7	B. The Louisiana Department of Health, office of behavioral health shall
8	work with the Department of State Civil Service to develop and make available
9	education and training material to assist statewide elected officials and state
10	legislators in complying with the requirements of this Section.
11	C. Each statewide elected official and each legislator shall submit
12	documentation to the appropriate human resource officer within his agency
13	confirming the receipt of the required mental health training.
14	§353. Required annual mental health counseling
15	A. Each statewide elected official and each legislator shall be required to
16	obtain at least five hours of mental health counseling each calendar year of his term
17	of office from an appropriate licensed health care professional.
18	B. Each statewide elected official and each legislator shall submit
19	documentation from the licensed healthcare professional to the appropriate human
20	resource officer within his agency affirming the receipt of the required mental health
21	counseling.

Abstract: Requires statewide elected officials and legislators receive at least one hour of annual mental health response training and five hours of professional mental health counseling each calendar year of office.

Proposed law provides for findings regarding the impact that mental health issues, including undiagnosed mental illness and related substance abuse has on all of our citizens.

CODING: Words in struck through type are deletions from existing law; words underscored are additions.

<u>Proposed law</u> provides that each calendar year each statewide elected official and each legislator is required to obtain at least one hour of education and training on recognizing the signs and symptoms suggestive of a potential mental health challenges and how to properly interact with a person experiencing a mental health crisis. Requires the La. Dept. of Health, office of behavioral health to work with the Dept. of State Civil Service to develop and make available education and training material to assist statewide elected officials and state legislators in complying with the education and training requirements. Requires documentation to be submitted to the appropriate agency human resource officer confirming receipt of the training.

<u>Proposed law</u> additionally requires each statewide elected official and each legislator to obtain at least five hours of mental health counseling each calendar year of his term of office from an appropriate licensed health care professional. Requires documentation to be submitted to the appropriate agency human resource officer confirming receipt of the counseling.
