RETIREMENT/TEACHERS: Provides for the reemployment of retirees of the Teachers' Retirement System of Louisiana in critical shortage positions

| 14 | retiree who is employed in a critical shortage position shall be governed by the |

| 16 | (2)(a) Except as provided in Subsection C of this Section, a retiree who is |
| 17 | employed in a critical shortage position may receive a benefit during the period of |
| 18 | his reemployment if the Board of Elementary and Secondary Education and the |
| 19 | board of trustees of this system have received certification that a critical shortage |
| 20 | exists. Prior to making such certification for any critical shortage position, the |
| 21 | employer shall satisfy the requirements of Subparagraph (b) of this Paragraph. If a |
| 22 | certified applicant who is not a retiree applies for an advertised position, such person |
| 23 | shall be hired before any certified retiree is employed, unless fewer than three |
| 24 | applicants have applied for the position, each of whom is certified in the critical |

| 28 | counselor, school psychologist, interpreter, educational transliterator, or educator of |
| 29 | the deaf or hard of hearing whose position of employment requires a valid Louisiana |

| 3 | (6) During the period of his return to active service under the provisions of |
| 4 | this Subsection, the retiree and his employer shall make contributions to the |
| 5 | retirement system as provided by this Chapter, but the retiree shall receive no |
| 6 | additional service credit and shall not accrue any additional retirement benefits in the |
| 7 | retirement system. Upon termination of active service, the retired teacher shall, upon |
| 8 | application, be refunded the employee contributions paid since reemployment. The |
| 9 | refund shall be without interest. The retirement system shall retain the employer |
| 10 | contributions. |
| 11 | Section 2. The cost of this Act, if any, shall be funded with additional employer |
| 12 | contributions in compliance with Article X, Section 29(F) of the Constitution of Louisiana. |
| 13 | Section 3. This Act shall become effective on July 1, 2024; if vetoed by the governor |
| 14 | and subsequently approved by the legislature, this Act shall become effective on July 1, |
| 15 | 2024, or on the day following such approval by the legislature, whichever is later. |

Abstract: Provides for reemployment of teachers in the Teachers' Retirement System of La. (TRSL) in a critical shortage position.

<u>Present law</u> governs the payment of benefits to retirees of the Teachers' Retirement System of Louisiana (TRSL) including retirees who return to work in positions covered by the retirement system. <u>Present law</u> generally requires a retiree's benefit to be suspended for the duration of reemployment with some exceptions. Requires suspension of benefit without exception for any reemployment within the first 12 months of retirement. Requires payment of employee contributions during reemployment. Provides for refund of employee contributions without interest after the reemployment ends.

Proposed law retains present law.

<u>Present law</u> allows retirees who retired on or before June 30, 2020, to be reemployed in fulltime critical shortage positions without a suspension of benefits.

Present law defines "critical shortage position" as follows:

(1) A K-12 classroom teacher where a critical shortage exists.

(2) A speech therapist, speech pathologist, audiologist, educational diagnostician, school social worker, school counselor, school psychologist, interpreter, educational transliterator, or educator of deaf or hard of hearing where a critical shortage exists.

<u>Present law</u> requires the employer to meet certain advertising and posting requirements before certifying the existence of a critical shortage. Requires the superintendent and personnel director of a school district to certify a critical shortage area to the State Bd. of Elementary and Secondary Education.

<u>Proposed law</u> makes <u>present law</u> authorizing reemployment of retirees in critical shortage areas without a suspension of benefits applicable to the following:

- (1) Retirees who retired on or before June 30, 2020, and who return to work in such a position on a part-time basis.
- (2) Retirees who retire after June 30, 2020, and who return to work in such a position on a full-time or part-time basis.

<u>Proposed law</u> requires that any cost of <u>proposed law</u> be funded with additional employer contributions in compliance with Art. X, Sec. 29(F) of the state constitution.

Effective July 1, 2024.
