| 16 | and are not intended to be heated or burned. Nicotine pouch products are hereby |
| 17 | deemed to be alternative nicotine products as defined in this Section. |

Nicotine pouch products are alternative nicotine products that are not subject
to the provisions of R.S. 26:926. Nicotine pouch products shall be subject to
regulation by the office of alcohol and tobacco and subject to R.S. 14:91.8.

Abstract: Provides relative to the vapor product and alternative nicotine product directory.

Present law provides for definitions.

Proposed law defines "nicotine pouch products".

<u>Present law</u> establishes the vapor product and alternative nicotine product directory.

<u>Present law</u> requires the commissioner to develop and maintain a directory listing all vapor product manufacturers and alternative nicotine product manufacturers that have provided certifications that comply with present law and all products listed in those certifications.

<u>Proposed law</u> exempts nicotine pouch products from the vapor product and alternative nicotine product directory.

(Adds R.S. 26:901(36) and 926.2)

Summary of Amendments Adopted by House

The House Floor Amendments to the engrossed bill:

1. Specify that "nicotine pouch products" are alternative nicotine products.
