## ECONOMIC DEVELOPMENT: Requires the recipient of certain economic development funds to adhere to certain hiring, purchasing, reporting, and repayment conditions

1	AN ACT
2	To enact R.S. 51:933, relative to economic development; to require any business that
3	receives a monetary incentive from the state to secure its presence in this state to
4	enter into a cooperative endeavor agreement with the state; to provide for the
5	minimum content of the cooperative endeavor agreement; and to provide for related
6	matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 51:933 is hereby enacted to read as follows:
9	§933. Cooperative endeavor agreement required for businesses receiving state funds
10	Any business that receives a monetary incentive from the state to secure its
11	presence in this state shall enter into a cooperative endeavor agreement with the state
12	prior to receiving the funds. The cooperative endeavor agreement shall include but
13	not be limited to the following terms and requirements:
14	(1) An agreement with a nongovernmental entity for economic development
15	purposes shall contain the specific goals sought to be achieved by the
16	nongovernmental entity and methods for reimbursement to the state if those goals
17	are not met. Further, a nongovernmental entity, other than one participating in a
18	business incubator program, Quality Jobs Program, or Enterprise Zone Program,
19	which defaults on the agreement, breaches the terms of the agreement, ceases to do

2	and the agreement shall set out the terms of the repayment.
3	(2) An agreement based on a legislative appropriation to a public or
4	quasi-public agency or entity which is not a state budget unit shall include a
5	comprehensive budget, provided to the agency and the legislative auditor, showing
6	all anticipated uses of the appropriation, an estimate of the duration of the project,
7	and a plan showing specific goals and objectives, including measures of
8	performance. Specific goals set forth shall include goals for utilizing Louisiana
9	Hudson Initiative and Veteran Initiative certified companies.
10	(3) All agreements shall contain a plan to monitor compliance with the terms
11	of the agreement, assigning a particular person within the Department of Economic
12	Development to be responsible for monitoring the agreement. Written reports shall
13	be provided to the Department of Economic Development at least every six months
14	concerning the use of funds and the specific goals and objectives for the use of the

Abstract: Requires any business that receives a monetary incentive from the state to secure its presence in this state to enter into a cooperative endeavor agreement requiring the business to adhere to certain hiring, purchasing, reporting, and repayment conditions.

<u>Proposed law</u> requires any business that receives a monetary incentive from the state to secure its presence in this state to enter into a cooperative endeavor agreement with the state prior to receiving the funds.

<u>Proposed law</u> provides that the cooperative endeavor agreement shall include but not be limited to the following terms and requirements:

(1) An agreement with a nongovernmental entity for economic development purposes shall contain the specific goals sought to be achieved by the nongovernmental entity and methods for reimbursement to the state if those goals are not met. Further, a nongovernmental entity, other than one participating in a business incubator program, Quality Jobs Program, or Enterprise Zone Program, which defaults on the agreement, breaches the terms of the agreement, ceases to do business, or ceases to do business in La., shall be required to repay the state, and the agreement shall set out the terms of the repayment.

- (2) An agreement based on a legislative appropriation to a public or quasi-public agency or entity which is not a state budget unit shall include a comprehensive budget, provided to the agency and the legislative auditor, showing all anticipated uses of the appropriation, an estimate of the duration of the project, and a plan showing specific goals and objectives, including measures of performance. Specific goals set forth shall include goals for utilizing La. Hudson Initiative and Veteran Initiative certified companies.
- (3) All agreements shall contain a plan to monitor compliance with the terms of the agreement, assigning a particular person within the Dept. of Economic Development to be responsible for monitoring the agreement. Written reports shall be provided to the Dept. of Economic Development at least every six months concerning the use of funds and the specific goals and objectives for the use of the funds.
