PRIVACY: Provides relative to the protection of data

1	AN ACT
2	To enact Chapter 12-B of Title 51 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 51:1381 through 1396, relative to data privacy; to provide
4	definitions; to provide for applicability; to provide for consumer rights; to require a
5	response to a request; to provide for the responsibilities of a processor and a
6	controller; to provide for deidentified data; to provide limitations; to provide for
7	investigative powers; to provide for enforcement; to provide for a civil fine; to create
8	an account; to require a report; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Chapter 12-B of Title 51 of the Louisiana Revised Statutes of 1950,
11	comprised of R.S. 51:1381 through 1396, is hereby enacted to read as follows:
12	CHAPTER 12-B. LOUISIANA CONSUMER PRIVACY ACT
13	<u>§1381. Short title</u>
14	This Chapter shall be known and may be cited as the "Louisiana Consumer
15	Privacy Act".
16	<u>§1382. Definitions</u>
17	As used in this Chapter, the following words have the following meanings:
18	(1) "Account" means the consumer privacy restricted account established in
19	<u>R.S. 51:1395.</u>
20	(2) "Affiliate" means an entity that satisfies either of the following criteria:

1	(a) Controls, is controlled by, or is under common control with another
2	entity.
3	(b) Shares common branding with another entity.
4	(3) "Aggregated data" means information that relates to a group or category
5	of consumers that satisfies all of the following criteria:
6	(a) All individual consumer identities have been removed from the
7	information.
8	(b) The information is not linked or reasonably linkable to any consumer.
9	(4) "Air carrier" means the same as that term is defined in 49 U.S.C. 40102.
10	(5) "Authenticate" means to use reasonable means to determine that a
11	consumer's request to exercise the rights described in R.S. 51:1385 is made by the
12	consumer who is entitled to exercise those rights.
13	(6)(a) "Biometric data" means data generated by automatic measurements of
14	an individual's unique biological characteristics.
15	(b) "Biometric data" includes data described in Subparagraph (a) of this
16	Paragraph that is generated by automatic measurements of an individual's fingerprint,
17	voiceprint, eye retinas, irises, or any other unique biological pattern or characteristic
18	that is used to identify a specific individual.
19	(c) "Biometric data" does not include any of the following:
20	(i) A physical or digital photograph.
21	(ii) A video or audio recording.
22	(iii) Data generated from an item described in Items (i) and (ii) of this
23	Subparagraph.
24	(iv) Information captured from a patient in a healthcare setting.
25	(v) Information collected, used, or stored for treatment, payment, or
26	healthcare operations as those terms are defined in 45 CFR Parts 160, 162, and 164.
27	(7) "Business associate" means the same as that term is defined in 45 CFR
28	<u>160.103.</u>
29	(8) "Child" means an individual younger than thirteen years old.

1	(9) "Consent" means an affirmative act by a consumer that unambiguously
2	indicates the consumer's voluntary and informed agreement to allow a person to
3	process personal data related to the consumer.
4	(10)(a) "Consumer" means an individual who is a resident of this state acting
5	in an individual or household context.
6	(b) "Consumer" does not include an individual acting in an employment or
7	commercial context.
8	(11) "Control" or "controlled" as used in Paragraph (2) of this Section means
9	any of the following:
10	(a) Ownership of, or the power to vote with, more than fifty percent of the
11	outstanding shares of any class of voting securities of an entity.
12	(b) Control in any manner over the election of a majority of the directors or
13	of the individuals exercising similar functions.
14	(c) The power to exercise controlling influence of the management of an
15	entity.
16	(12) "Controller" means a person doing business in this state who determines
17	the purposes for which and the means by which personal data is processed,
18	regardless of whether the person makes the determination alone or with others.
19	(13) "Covered entity" means the same as that term is defined in 45 CFR
20	<u>160.103.</u>
21	(14) "Deidentified data" means data that satisfies all of the following criteria:
22	(a) Cannot reasonably be linked to an identified individual or an identifiable
23	individual.
24	(b) Is possessed by a controller who does all of the following:
25	(i) Takes reasonable measures to ensure that a person cannot associate the
26	data with an individual.
27	(ii) Publicly commits to maintain and use the data only in its deidentified
28	form and further commits to not attempt to reidentify the data.

1	(iii) Contractually obligates any recipients of the data to comply with the
2	requirements described in Items (i) and (ii) of this Subparagraph.
3	(15) "Director" means the director of the Consumer Protection section of the
4	Department of Justice.
5	(16) "Division" means the Consumer Protection section of the Department
6	of Justice.
7	(17) "Governmental entity" means any board, authority, commission,
8	department, office, division, or agency of this state or any of its local political
9	subdivisions.
10	(18) "Healthcare facility" means an institution providing medical services
11	or a healthcare setting, including but not limited to a hospital or other licensed
12	inpatient center, an ambulatory surgical or treatment center, a skilled nursing center,
13	a residential treatment center, a rehabilitation center, and a diagnostic, laboratory, or
14	imaging center.
15	(19) "Healthcare provider" means any person licensed, certified, or
16	registered in this state to provide healthcare services, including but not limited to
17	physicians, hospitals, home health agencies, chiropractors, pharmacies, and dentists.
18	(20) "Identifiable individual" means an individual who can be readily
19	identified, either directly or indirectly.
20	(21) "Institution of higher education" means a public or private institution
21	of higher education.
22	(22) "Local political subdivision" means a parish, municipality, and any
23	other unit of local government, including but not limited to a school board or a
24	special district, authorized by law to perform governmental functions.
25	(23) "Nonprofit corporation" means any of the following:
26	(a) A corporation incorporated in accordance with the laws of this state and
27	subject to the provisions of the Nonprofit Corporation Law R.S. 12:01 et seq.

1	(b) A corporation incorporated in accordance with the laws of another state
2	that would be considered a nonprofit corporation if it were incorporated in
3	accordance with the laws of this state.
4	(24)(a) "Personal data" means information that is linked or reasonably
5	linkable to an identified individual or an identifiable individual.
6	(b) "Personal data" does not include deidentified data, aggregated data, or
7	publicly available information.
8	(25) "Process" means an operation or set of operations performed on
9	personal data, including but not limited to collection, use, storage, disclosure,
10	analysis, deletion, or modification of personal data.
11	(26) "Processor" means a person who processes personal data on behalf of
12	a controller.
13	(27) "Protected health information" means the same as that term is defined
14	<u>in 45 CFR 160.103.</u>
15	(28) "Pseudonymous data" means personal data that cannot be attributed to
16	a specific individual without the use of additional information, if the additional
17	information satisfies all of the following criteria:
18	(a) Is kept separate from the consumer's personal data.
19	(b) Is subject to appropriate technical and organizational measures to ensure
20	that the personal data is not attributable to an identified individual or an identifiable
21	individual.
22	(29) "Publicly available information" means information that satisfies any
23	of the following criteria:
24	(a) Is lawfully obtained by a person from a record of a governmental entity.
25	(b) Is obtained by a person who reasonably believes a consumer or a widely-
26	distributed media source has lawfully made available to the general public.
27	(c) Is obtained from a person to whom the consumer disclosed the
28	information, if the consumer has not restricted the information to a specific audience.
29	(30) "Right" means a consumer right described in R.S. 51:1385.

1	(31)(a) "Sale", "sell", or "sold" means the exchange of personal data for
2	monetary consideration by a controller to a third party.
3	(b) "Sale", "sell", or "sold" does not include:
4	(i) A controller's disclosure of personal data to a processor who processes the
5	personal data on behalf of the controller.
6	(ii) A controller's disclosure of personal data to an affiliate of the controller.
7	(iii) Considering the context in which the consumer provided the personal
8	data to the controller, a controller's disclosure of personal data to a third party if the
9	purpose is consistent with a consumer's reasonable expectations.
10	(iv) The disclosure or transfer of personal data if a consumer directs a
11	controller to do either of the following:
12	(aa) Disclose the personal data.
13	(bb) Interact with one or more third parties.
14	(v) A consumer's disclosure of personal data to a third party for the purpose
15	of providing a product or service requested by the consumer or a parent or legal
16	guardian of a child.
17	(vi) The disclosure of information, if the consumer satisfies all of the
18	following criteria:
19	(aa) Intentionally makes available to the general public via a channel of mass
20	media.
21	(bb) Does not restrict the information to a specific audience.
22	(vii) A controller's transfer of personal data to a third party as an asset that
23	is part of a proposed or actual merger, an acquisition, or a bankruptcy in which the
24	third party assumes control of all or part of the controller's assets.
25	(32)(a) "Sensitive data" means any of the following:
26	(i) Personal data that reveals any of the following:
27	(aa) An individual's racial or ethnic origin.
28	(bb) An individual's religious beliefs.
29	(cc) An individual's sexual orientation.

1	(dd) An individual's citizenship or immigration status.
2	(ee) Information regarding an individual's medical history, mental or
3	physical health condition, or medical treatment or diagnosis by a healthcare
4	professional.
5	(ii) The processing of genetic personal data or biometric data, if the
6	processing is for the purpose of identifying a specific individual.
7	(iii) Specific geolocation data.
8	(b) "Sensitive data" does not include personal data that reveals any of the
9	following, if processed in the manner provided:
10	(i) Racial or ethnic origin, if the personal data is processed by a video
11	communication service.
12	(ii) Any information regarding an individual's medical history, mental or
13	physical health condition, or medical treatment or diagnosis by a healthcare
14	professional, if the personal data is processed by a person licensed to provide health
15	care in accordance with the laws of this state.
16	(33)(a) "Specific geolocation data" means information derived from
17	technology, including global positioning system level latitude and longitude
18	coordinates, that directly identifies an individual's specific location, accurate within
19	a radius of one thousand seven hundred fifty feet or fewer.
20	(b) "Specific geolocation data" does not include either of the following:
21	(i) The content of a communication.
22	(ii) Any data generated by or connected to advanced utility metering
23	infrastructure systems or equipment for use by a utility.
24	(34)(a) "Targeted advertising" means displaying an advertisement to a
25	consumer where the advertisement is selected based on personal data obtained from
26	the consumer's activities over time and across nonaffiliated websites or online
27	applications to predict the consumer's preferences or interests.
28	(b) "Targeted advertising" does not include any of the following:

1	(i) Advertising based on a consumer's activities within a controller's website
2	or online application or any affiliated website or online application.
3	(ii) Advertising based on the context of a consumer's current search query
4	or visit to a website or online application.
5	(iii) Advertising directed to a consumer in response to the consumer's request
6	for information, products, services, or feedback.
7	(iv) Processing personal data solely to measure or report on advertising
8	performance, advertising reach, or advertising frequency.
9	(35) "Third party" means a person other than the following:
10	(a) The consumer, controller, or processor.
11	(b) An affiliate or contractor of the controller or the processor.
12	(36) "Trade secret" means information, including a formula, pattern,
13	compilation, program, device, method, technique, or process that satisfies all of the
14	following criteria:
15	(a) Derives independent economic value, actual or potential, from not being
16	generally known or readily ascertainable by proper means by other persons who can
17	obtain economic value from the information's disclosure or use.
18	(b) Is the subject of efforts that are reasonable under the circumstances to
19	maintain the information's secrecy.
20	<u>§1383. Applicability</u>
21	A. The provisions of this Chapter apply to any controller or processor who
22	conducts business in this state or produces a product or service that is targeted to
23	consumers who are residents of this state who satisfy both of the following:
24	(1) Has annual revenue of twenty-five million dollars or more.
25	(2) Satisfies any of the following criteria:
26	(a) During a calendar year, controls or processes the personal data of at least
27	one hundred thousand consumers.

1	(b) Derives over fifty percent of the entity's gross revenue from the sale of
2	personal data and controls or processes the personal data of twenty-five thousand or
3	more consumers.
4	B. The provisions of this Chapter do not apply to any of the following:
5	(1) A governmental entity or a third party under contract with a
6	governmental entity when the third party is acting on behalf of the governmental
7	entity.
8	(2) A tribe.
9	(3) An institution of higher education.
10	(4) A nonprofit corporation.
11	(5) A covered entity.
12	(6) A business associate.
13	(7) Protected health information for purposes of the Health Insurance
14	Portability and Accountability Act of 1996, 42 U.S.C. 1320d et seq., and related
15	regulations.
16	(8) Patient identifying information for purposes of 42 CFR Part 2.
17	(9) Identifiable private information for purposes of the Federal Policy for the
18	Protection of Human Subjects, 45 CFR Part 46.
19	(10) Identifiable private information or personal data collected as part of
20	human subjects research pursuant to or under the same standards as either of the
21	following:
22	(a) The good clinical practice guidelines issued by the International Council
23	for Harmonisation.
24	(b) The Protection of Human Subjects as provided in 21 CFR Part 50 and
25	Institutional Review Boards as provided in 21 CFR Part 56.
26	(11) Personal data used or shared in research conducted in accordance with
27	one or more of the requirements described in Paragraph (9) of this Subsection.
28	(12) Information and documents created specifically for, and collected and
29	maintained by the Louisiana Department of Health.

1	(13) Information and documents created for purposes of the federal Health
2	Care Quality Improvement Act of 1986, 42 U.S.C. 11101 et seq., and related
3	regulations.
4	(14) Patient safety work product for purposes of 42 CFR Part 3.
5	(15) Information that satisfies all of the following criteria:
6	(a) Deidentified in accordance with the requirements for deidentification set
7	forth in 45 CFR Part 164.
8	(b) Derived from any of the healthcare-related information listed in
9	Paragraphs (7) through (14) of this Subsection.
10	(16) Information originating from or indistinguishably intermingled with
11	information provided for in Paragraphs (7) through (14) of this Subsection that is
12	maintained by either of the following:
13	(a) A healthcare facility or healthcare provider.
14	(b) A program or a qualified service organization as defined in 42 CFR 2.11.
15	(17) Information used only for public health activities and purposes as
16	described in 45 CFR 164.512.
17	(18)(a) An activity by any of the following, if all of the criteria provided in
18	Subparagraphs (b) and (c) of this Paragraph are satisfied:
19	(i) A consumer reporting agency, as defined in 15 U.S.C. Sec. 1681a.
20	(ii) A furnisher of information, as set forth in 15 U.S.C. Sec. 1681s-2, who
21	provides information for use in a consumer report, as defined in 15 U.S.C. Sec.
22	<u>1681a.</u>
23	(iii) A user of a consumer report, as set forth in 15 U.S.C. Sec. 1681b.
24	(b) The activity is subject to regulation under the federal Fair Credit
25	Reporting Act, 15 U.S.C. 1681 et seq.
26	(c) The activity involves the collection, maintenance, disclosure, sale,
27	communication, or use of any personal data that bears on any of the following
28	relative to the consumer:
29	(i) Credit worthiness.

1	(ii) Credit standing.
2	(iii) Credit capacity.
3	(iv) Character.
4	(v) General reputation.
5	(vi) Personal characteristics.
6	(vii) Mode of living.
7	(19) A financial institution or an affiliate of a financial institution governed
8	by, or personal data collected, processed, sold, or disclosed in accordance with, Title
9	V of the Gramm-Leach-Bliley Act, 15 U.S.C. 6801 et seq. and related regulations.
10	(20) Personal data collected, processed, sold, or disclosed in accordance with
11	the federal Driver's Privacy Protection Act of 1994, 18 U.S.C. 2721 et seq.
12	(21) Personal data regulated by the federal Family Education Rights and
13	Privacy Act, 20 U.S.C. 1232g and related regulations.
14	(22) Personal data collected, processed, sold, or disclosed in accordance with
15	the federal Farm Credit Act of 1971, 12 U.S.C. 2001 et seq.
16	(23) Data that is processed or maintained in any of the following manners:
17	(a) In the course of an individual applying to, being employed by, or acting
18	as an agent or independent contractor of a controller, processor, or third party, to the
19	extent the collection and use of the data are related to the individual's role.
20	(b) As the emergency contact information of an individual described in
21	Subparagraph (a) of this Paragraph and used for emergency-contact purposes.
22	(c) To administer benefits for another individual relating to an individual
23	described in Subparagraph (a) of this Paragraph and used for the purpose of
24	administering the benefits.
25	(24) An individual's processing of personal data for purely personal or
26	household purposes.
27	(25) An air carrier.
28	C. A controller is in compliance with any obligation to obtain parental
29	consent pursuant to this Chapter if the controller complies with the verifiable

1	parental consent mechanisms as provided in the Children's Online Privacy Protection
2	Act, 15 U.S.C. 6501 et seq. and the act's implementing regulations and exemptions.
3	D. This Chapter does not require a person to take any action in conflict with
4	the federal Health Insurance Portability and Accountability Act of 1996, 42 U.S.C.
5	1320d et seq. or related regulations.
6	§1384. Preemption
7	A. The provisions of this Chapter supersede and preempt any ordinance,
8	resolution, rule, or other regulation adopted by a local political subdivision regarding
9	the processing of personal data by a controller or processor.
10	B. Any reference to federal law in this Chapter includes any rules or
11	regulations promulgated pursuant to that federal law.
12	<u>§1385. Consumer rights</u>
13	A. A consumer has the right to do all of the following:
14	(1) Confirm whether a controller is processing the consumer's personal data.
15	(2) Access the consumer's personal data.
16	(3) Obtain a copy of the consumer's personal data, that the consumer
17	previously provided to the controller, in a format that satisfies all of the following:
18	(a) To the extent technically feasible, is portable.
19	(b) To the extent practicable, is readily usable.
20	(c) Allows the consumer to transmit the data to another controller without
21	impediment, if the processing is carried out by automated means.
22	(4) Delete the consumer's personal data that the consumer provided to the
23	controller.
24	(5) A consumer has the right to opt out of the processing of the consumer's $(5)$
25	personal data for either of the following purposes:
26	(a) Targeted advertising.
27	(b) The sale of personal data.
28	B. Nothing in this Section requires a person to cause a breach of security
29	system as defined in R.S. 51:3073.

1	§1386. Exercising consumer rights
2	A. A consumer may exercise a right provided for in R.S. 51:1385 by
3	submitting a request to a controller, by means prescribed by the controller,
4	specifying the right the consumer intends to exercise.
5	B. In the case of processing personal data concerning a known child, the
6	parent or legal guardian of the known child shall exercise a right on the child's
7	behalf.
8	C. In the case of processing personal data concerning a consumer subject to
9	a guardianship, conservatorship, or other protective arrangement, the guardian or the
10	conservator of the consumer shall exercise a right on the consumer's behalf.
11	<u>§1387.</u> Controller's response to request
12	A. Subject to the other provisions of this Chapter, a controller shall comply
13	with a consumer's request to exercise a right pursuant to R.S. 51:1386.
14	<u>B.(1)</u> Within forty-five days of receiving a request to exercise a right, the
15	controller shall do both of the following:
16	(a) Take action on the consumer's request.
17	(b) Inform the consumer of any action taken on the consumer's request.
18	(2) The controller may extend the initial forty-five-day period by an
19	additional forty-five days, if reasonably necessary due to the complexity of the
20	request or the volume of the requests received by the controller. The controller may
21	extend the period only once.
22	(3) If a controller extends the initial forty-five-day period, before the initial
23	forty-five-day period expires, the controller shall do all of the following:
24	(a) Inform the consumer of the extension, including the length of the
25	extension.
26	(b) Provide the reasons the extension is reasonably necessary as described
27	in Paragraph (2) of this Subsection.

1	(4) The forty-five-day period does not apply if the controller reasonably
2	suspects the consumer's request is fraudulent, and the controller is not able to
3	authenticate the request before the forty-five-day period expires.
4	(5) If, in accordance with the provision of this Section, a controller chooses
5	not to take action on a consumer's request, the controller shall, within forty-five days
6	after the day on which the controller receives the request, inform the consumer of the
7	reasons for not taking action.
8	D.(1) A controller may not charge a fee for information in response to a
9	request, unless the request is the consumer's second or subsequent request during the
10	same twelve-month period.
11	(2)(a) Notwithstanding Paragraph (1) of this Subsection, a controller may
12	charge a reasonable fee to cover the administrative costs of complying with a request
13	or may refuse to act on a request, if any of the following is true:
14	(i) The request is excessive, repetitive, technically infeasible, or manifestly
15	unfounded.
16	(ii) The controller reasonably believes the consumer's primary purpose in
17	submitting the request was something other than exercising a right.
18	(iii) The request, individually or as part of an organized effort, harasses,
19	disrupts, or imposes an undue burden on the resources of the controller's business.
20	(b) A controller that charges a fee or refuses to act in accordance with this
21	Subsection bears the burden of demonstrating the request satisfied one or more of the
22	criteria described in Subparagraph (D)(2)(a) of this Subsection.
23	E. If a controller is unable to authenticate a consumer request to exercise a
24	right described in R.S. 51:1385 using commercially-reasonable efforts, the controller
25	is not required to comply with the request and may request that the consumer provide
26	additional information reasonably necessary to authenticate the request.
27	§1388. Responsibility according to role
28	A. A processor shall do both of the following:
29	(1) Adhere to the controller's instructions.

1	(2) Taking into account the nature of the processing and information
2	available to the processor, by appropriate technical and organizational measures,
3	insofar as reasonably practicable, assist the controller in meeting the controller's
4	obligations, including obligations related to the security of processing personal data
5	and notification of a breach of a security system described in R.S. 51:3073.
6	B. Before a processor performs processing on behalf of a controller, the
7	processor and controller shall enter into a contract that satisfies all of the following
8	criteria:
9	(1) Clearly sets forth instructions for processing personal data, the nature and
10	purpose of the processing, the type of data subject to processing, the duration of the
11	processing, and the parties' rights and obligations.
12	(2) Requires the processor to ensure each person processing personal data
13	is subject to a duty of confidentiality with respect to the personal data.
14	(3) Requires the processor to engage any subcontractor pursuant to a written
15	contract that requires the subcontractor to meet the same obligations as the processor
16	with respect to the personal data.
17	C.(1) Determining whether a person is acting as a controller or processor
18	with respect to a specific processing of data is a fact-based determination that
19	depends upon the context in which personal data is to be processed.
20	(2) A processor that adheres to a controller's instructions with respect to a
21	specific processing of personal data remains a processor.
22	<u>§1389. Responsibilities of controllers</u>
23	A.(1) A controller shall provide consumers with a reasonably accessible and
24	clear privacy notice that includes all of the following:
25	(a) The categories of personal data processed by the controller.
26	(b) The purposes for which the categories of personal data are processed.
27	(c) How consumers may exercise a right.
28	(d) The categories of personal data that the controller shares with third
29	parties, if any.

1	(e) The categories of third parties, if any, with whom the controller shares
2	personal data.
3	(2) If a controller sells a consumer's personal data to one or more third
4	parties or engages in targeted advertising, the controller shall clearly and
5	conspicuously disclose to the consumer the manner in which the consumer may
6	exercise the right to opt out of each of the following:
7	(a) Processing for targeted advertising.
8	(b) Sale of the consumer's personal data
9	B.(1) A controller shall establish, implement, and maintain reasonable
10	administrative, technical, and physical data security practices designed to satisfy all
11	of the following criteria:
12	(a) Protect the confidentiality and integrity of personal data.
13	(b) Reduce reasonably foreseeable risks of harm to consumers relating to the
14	processing of personal data.
15	(2) Considering the controller's business size, scope, and type, a controller
16	shall use data security practices that are appropriate for the volume and nature of the
17	personal data at issue.
18	C. Except as otherwise provided for in this Chapter, a controller shall not
19	process sensitive data collected from a consumer without doing either of the
20	following:
21	(1) Presenting the consumer with clear notice and an opportunity to opt out
22	of the processing, prior to the data being processed.
23	(2) Processing the data in accordance with the federal Children's Online
24	Privacy Protection Act, 15 U.S.C. 6501 et seq., and the act's implementing
25	regulations and exemptions, in the case of the processing of personal data concerning
26	<u>a known child.</u>
27	D.(1) A controller may not discriminate against a consumer for exercising
28	a right by doing any of the following:
29	(a) Denying a good or service to the consumer.

1	(b) Charging the consumer a different price or rate for a good or service.
2	(c) Providing the consumer a different level of quality of a good or service.
3	(2) This Subsection does not prohibit a controller from offering a different
4	price, rate, level, quality, or selection of a good or service to a consumer, including
5	offering a good or service for no fee or at a discount, if either of the following is true:
6	(a) The consumer has opted out of targeted advertising.
7	(b) The offer is related to the consumer's voluntary participation in a bona
8	fide loyalty, rewards, premium features, discounts, or club card program.
9	E. A controller is not required to provide a product, service, or functionality

Abstract: Establishes consumer rights relative to data processing.

Proposed law shall be known and may be cited as "The Louisiana Consumer Privacy Act".

<u>Proposed law</u> defines "account", "affiliates", "aggregated data", "air carrier", "authenticate", "biometric data", "business associate", "child", "consent", "consumer", "control", "controller", "covered entity", "deidentified data", "director", "division", "governmental entity", "health care facility", "health care provider", "identifiable individual", "institution of higher education", "local political subdivision", "nonprofit corporation", "personal data", "process", "processor", "protected health information", "pseudonymous data", "publicly available information", "right", "sale", "sensitive data", "specific geolocation data", "targeted advertising", "third party", and "trade secret".

<u>Proposed law</u> applies to a controller or a processor who conducts business in this state or targets a product or service to residents of this state, has annual revenue of at least \$25,000,000, and satisfies either of the following:

- (1) During a calendar year, controls or processes the personal data of at least 100,000 consumers.
- (2) Derives over 50% of his gross revenue from selling personal data and controls or processes the personal data of at least 25,000 consumers.

<u>Proposed law</u> does not apply to any of the following:

- (1) A governmental agency or a third party who has a contract with that governmental entity and acting on the entity's behalf.
- (2) A tribe.
- (3) An institution of higher education.
- (4) A nonprofit corporation.
- (5) A covered entity.
- (6) A business associate.
- (7) Certain protected health information.
- (8) Certain identifying information.
- (9) Certain information collected, processed, sold, or regulated pursuant to federal law.
- (10) Information that has become intermingled with and indistinguishable from certain exempted information.

- (11) Activity by a consumer reporting agency, a furnisher of information, or a user of a consumer report, if the activity is subject to the federal fair credit reporting act and involves the collection, maintenance, disclosure, sale, communication, or use of any personal data that bears on certain enumerated factors.
- (12) A financial institution governed by federal law.
- (13) Data that is processed or maintained relative to employment, emergency contact information, or administration of benefits.
- (14) Personal or household processing.
- (15) An air carrier.

<u>Proposed law</u> cites federal law as the operating standard for compliance with any obligation to obtain parental consent.

Proposed law preempts any conflicting local regulation.

<u>Proposed law</u> provides that a consumer has the right to do all of the following:

- (1) Confirm whether a controller is processing his data.
- (2) Access his personal data.
- (3) Obtain a copy of his personal data.
- (4) Delete the data provided to him by the controller.
- (5) Opt out of the processing of data for the purposes of targeted advertising or the sale of personal data.

A consumer or legal representative of the consumer may exercise the rights provided in <u>proposed law</u> by submitting a request to the controller, in a means prescribed by the controller.

<u>Proposed law</u> requires a controller to comply with a consumers request to exercise a right provided for in <u>proposed law</u> and further requires the controller take action and notify the consumer of such action within 45 days of receipt of the request.

<u>Proposed law</u> allows the controller to extend the response time by an additional 45 days if reasonably necessary. The controller is required to notify the consumer if the time period for action is extended and provide a reason for the extension.

<u>Proposed law</u> does not require a controller to comply with the 45-day limit if he reasonably suspects fraud and cannot authenticate the request prior to lapse of the 45 days.

If a controller chooses not to take action on a request, <u>proposed law</u> requires the controller to notify the consumer of the reason for not taking action within 45 days of receiving the request.

<u>Proposed law</u> prohibits the controller from charging a fee for information in response to a request, unless any of the following is true:

- (1) The request is the consumer's second or subsequent request during the same 12month period.
- (2) The request is excessive, repetitive, technically infeasible, or manifestly unfounded.

- (3) The controller believes that the consumer's primary purpose in making the request was not to exercise a right provided in <u>proposed law</u>.
- (4) The request harasses, disrupts, or places an undue burden on the controller's business.

A controller who charges a fee based on the exceptions in <u>proposed law</u> bears the burden of proving that the necessary criteria is met.

<u>Proposed law</u> allows a controller to request additional information from a consumer if reasonably necessary to respond to the request.

<u>Proposed law</u> requires a processor to adhere to the controller's instructions and assist the controller in meeting his obligations, to the extent practicable.

Prior to performing on behalf of a controller, <u>proposed law</u> requires the processor and controller to enter into a contract. <u>Proposed law</u> requires that the contract contain clear instructions, a duty of confidentiality, and certain provisions relative to subcontractors.

<u>Proposed law</u> provides for the determination of a person as a controller or processor.

<u>Proposed law</u> requires a controller to provide consumers with a clear and accessible privacy notice containing all of the following:

- (1) The categories of data processed by the controller.
- (2) The purposes for which the data is being processed.
- (3) How consumers can exercise a right provided in proposed law.
- (4) The categories of data the controller shares with third party.
- (5) The categories of third parties the controller shares data with.

<u>Proposed law</u> requires a controller to disclose to the consumer the manner in which he may opt out of processing for targeted advertising or sale of his data.

<u>Proposed law</u> requires a controller to create and maintain reasonable and appropriate data security practices that protect the confidentiality and integrity of personal data and reduce harm to consumers.

<u>Proposed law</u> prohibits a controller from processing sensitive data without first notifying the consumer of his right to opt out. <u>Proposed law</u> defers to federal law if the personal data belongs to a child.

<u>Proposed law</u> prohibits a controller from discriminating against a consumer for exercising a right provided in <u>proposed law</u>.

<u>Proposed law</u> does not require a controller to provide a product, service, or functionality to a consumer in certain circumstances.

<u>Proposed law</u> cannot be waived or limited through a contractual provision.

<u>Proposed law</u> does not require a controller or processor to do any of the following, as long as the controller does not engage in certain prohibited activity:

- (1) Reidentify certain data.
- (2) Maintain data in an identifiable form.

(3) Comply with a request that is not reasonably associated with the personal data or it would be unreasonably burdensome to do so.

The rights provided in <u>proposed law</u> are not applicable to pseudonymous data in certain circumstances.

<u>Proposed law</u> requires a controller who uses pseudonymous or deidentified data to take reasonable steps to ensure that he complies with all contractual obligations relative to that data and to promptly address any breach of the contract.

<u>Proposed law</u> does not restrict a controller or processor from doing any of the following:

- (1) Complying with any law or legal order.
- (2) Cooperating with law enforcement.
- (3) Participating in a legal claim,
- (4) Providing a requested service or product.
- (5) Performing a contract.
- (6) Protecting an interest essential for life or physical safety.
- (7) Taking necessary steps in response to certain incidents.
- (8) Taking actions relative to the integrity or security of systems.
- (9) Engaging in certain research.
- (10) Assisting another person in exercising a right provided in proposed law.
- (11) Processing personal data for certain purposes.
- (12) Retaining a consumer's email address to comply with his request.

<u>Proposed law</u> does not apply if compliance by the controller or processor would result in a violation of an evidentiary rule or privilege or would adversely affect the privacy rights of another.

A controller or processor is not in violation of <u>proposed law</u> if he provides data to a third party in accordance with <u>proposed law</u> and the third party then processes the data in violation of <u>proposed law</u>, if he had no knowledge of the intent to commit a violation.

If a controller or processor processes data pursuant to an exception in <u>proposed law</u>, he bears the burden of proving that the necessary criteria are met.

Proposed law does not allow any person to disclose a trade secret.

A violation of proposed law does not provide a basis for a private cause of action.

<u>Proposed law</u> requires that a system to receive consumer complaints be established and administered by the Consumer Protection Division within the Dept. of Justice (division).

<u>Proposed law</u> allows the division to investigate complaints and refer the matter to the attorney general if a violation is substantiated.

The attorney general has the exclusive authority to enforce proposed law.

<u>Proposed law</u> requires the attorney general to provide notice and explanation to a controller or processor at least 30 days prior to initiating an enforcement action.

If the controller or processor cures the noticed violation within 30 days of receipt of notice and provides attestation to the attorney general, <u>proposed law</u> prohibits the attorney general from initiating the action.

<u>Proposed law</u> allows the attorney general to initiate an action if the controller continues to violate <u>proposed law</u> after remedying the problem and providing notice.

The attorney general may recover actual damages to the consumer and up to \$7,500 per violation of <u>proposed law</u>.

If a controller and processor are involved in the same violation of <u>proposed law</u>, comparative fault is used to allocate liability.

<u>Proposed law</u> creates the Consumer Privacy Account (account) where all monies received from an action arising out of <u>proposed law</u> are to be deposited.

The money in the account may be used for investigative and administrative costs, recovery of costs and attorney's fees, and consumer and business education programs.

If the balance in the account exceeds \$4,000,000 at the close of any fiscal year, all funds in excess of \$4,000,000 are to be deposited into the general fund.

<u>Proposed law</u> requires the division and the attorney general to submit a report evaluating and summarizing various aspects of <u>proposed law</u>. The report is to be submitted to the House and Senate commerce committees before July 1, 2025.
