**Abstract:** Relative to TOPS, provides for the repayment of a TOPS award for any particular semester (or equivalent time period) during the first two award years when it is determined that the student during that particular semester failed to meet applicable program requirements relative to making steady academic progress or maintaining full-time standing. Applies to those students who first qualify for a program award for the 2011-2012 award year and any award year thereafter.

<u>Proposed law</u>, relative to the Taylor Opportunity Program for Students, provides (notwithstanding any provision of <u>present law</u> to the contrary and in addition to any other eligibility requirements provided by <u>present law</u> for a student to initially receive and to continue to receive a program award) that for a student to be eligible to have an award payment during the first two award years, the student, for any particular semester or other applicable time period, shall agree to and be required to repay such award amount upon a determination by the agency that the student, during that particular semester or other applicable time period, failed to meet any of the requirements provided by <u>present law</u> (as may be applicable) relative to making steady academic progress or maintaining full-time standing for continuing in the program.

Provides that <u>proposed law</u> provisions are applicable to those students who first qualify for a program award for the 2011-2012 award year and any award year thereafter.
