A CONCURRENT RESOLUTION

To express the condolences of the Legislature of Louisiana upon the death of Thomas Anthony "Tony" Tramonte.

WHEREAS, it is with immense sadness and profound regret that the House of Representatives of the Legislature of Louisiana has learned of the passing, on April 29, 2024, of Thomas Anthony "Tony" Tramonte; and

WHEREAS, Tony was born on June 29, 1969, in Lake Charles, Louisiana, to Nicholas J. and Dell Greenlee Tramonte; he received a Catholic education, which he was extremely proud of, and he graduated from high school in 1988; and

WHEREAS, Tony attended McNeese State University, where he studied business management and marketing; he was a military veteran, having served his country as a member of the National Guard during Operation Desert Storm; and

WHEREAS, in addition to his civic service, Mr. Tramonte worked for more than twenty-five years in the automotive industry; he last served as the fleet and commercial manager at Mike Willis Ford in Sulphur, Louisiana; he was a dedicated fan of the Sulphur Tors and could often be heard cheering for them every Friday; and

WHEREAS, Tony leaves to cherish his memory his beloved wife of thirty-three years, Kristi Simon Tramonte; children, Nicholas Tramonte (Bethany) and Bryce Tramonte Trahan (Stryker); mother, Dell Faye Tramonte; grandchildren, Cruz Tramonte, Rhodes

Tramonte, Grey Tramonte, Kyle Trahan, and Kolby Trahan; sisters, Kelly Billeaudeaux (Kirk), Beth Land (David), and Michelle Tramonte; mother- and father-in-law, Vicki Gaspard and Marvin Gaspard; and a host of nieces, nephews, and godchildren; he will be deeply missed, but the legacy of his loving life will live on in the hearts and minds of those who had the privilege of knowing and loving him.
