MEDICAID: Creates a task force to study the potential expansion of behavioral healthcare providers eligible for enhanced Medicaid reimbursement

A CONCURRENT RESOLUTION

2	To create a task force to study the potential expansion of behavioral healthcare providers
3	who are eligible for enhanced Medicaid reimbursement.
4	WHEREAS, it is critical for this legislature to address the mental health crisis in this
5	state; and
6	WHEREAS, many Louisiana residents who suffer with mental health disorders are
7	Medicaid enrollees; and
8	WHEREAS, in 2022, the office of behavioral health within the Louisiana Department
9	of Health introduced the Louisiana Crisis Response System in an effort to address the mental
10	health issues of Medicaid recipients in this state; and
11	WHEREAS, the Louisiana Crisis Response System focused on expanding services
12	to Louisiana Medicaid members experiencing a mental health crisis with the phased
13	implementation of a comprehensive crisis system of care; and
14	WHEREAS, individuals age twenty-one and older who are served by one of the five
15	Medicaid Healthy Louisiana plans and experiencing emotional distress were granted access
16	to a continuum of voluntary crisis services through the implementation of the program; and
17	WHEREAS, such voluntary crisis services are built on principles of recovery and
18	aim to divert from unnecessary hospitalizations and institutional levels of care; and
19	WHEREAS, the program encompasses services via Mobile Crisis Response,
20	Community Brief Crisis Support, Behavioral Health Crisis Care, and Crisis Stabilization;

1	WHEREAS, services for the program are active in the Greater New Orleans region,
2	the Greater Baton Rouge region, the South-Central Louisiana region, the Northwest
3	Louisiana region, and Jefferson Parish; and
4	WHEREAS, although the efforts of the Louisiana Crisis Response System do not go
5	unnoticed, the residents in this state are still facing challenges with mental health; and
6	WHEREAS, further expansion of the pool of behavioral healthcare providers eligible
7	for enhanced Medicaid dollars may aid the state in addressing this matter; and
8	WHEREAS, the inclusion of healthcare providers with a master of social work and
9	other master's-level behavioral healthcare providers, including but not limited to mental
10	health counselors, may also help the statewide epidemic; and
11	WHEREAS, it is the duty of this legislature to consider expanding the pool of
12	behavioral healthcare providers who are eligible for enhanced Medicaid dollars and
13	potentially including other healthcare providers in its expansion.
14	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
15	create a task force to study the potential expansion of behavioral healthcare providers who
16	are eligible for enhanced Medicaid reimbursement.
17	BE IT FURTHER RESOLVED that the task force shall consist of members from the
18	following associations, boards, departments, and organizations:
19	(1) The president of the Louisiana School Psychologist Association or his designee.
20	(2) The president of the Louisiana Association of School Social Workers or his
21	designee.
22	(3) A member of the Legislative Youth Advisory Council in Louisiana who shall be
23	appointed by the chair of the Louisiana Commission on Civic Education.
24	(4) The secretary of the Louisiana Department of Health or his designee.
25	(5) The superintendent of the Louisiana Department of Education or his designee.
26	(6) The administrator of the Louisiana State Board of Social Work Examiners or his
27	designee.
28	(7) The president of the Louisiana Counseling Association or his designee.
29	(8) The president of the Louisiana Association of Child Welfare and Attendance or
30	his designee.

1 (9) The president of the Louisiana State Nurses Association or his designee.

- 2 (10) The executive director of the Louisiana State Board of Examiners of 3 Psychologists or his designee.
- 4 (11) The chair of the Louisiana Behavior Analyst Board or his designee.
- 5 (12) The president of the Louisiana School Counselors Association or his designee.
- 6 (13) The president of the Louisiana Center for Health Equity or his designee.
- 7 (14) The executive director of the Louisiana State Board of Licensed Professional 8 Counselors or his designee.
- 9 (15) The director of the Louisiana Managed Medicaid Association or his designee.
- BE IT FURTHER RESOLVED that members of the task force shall study and provide information and recommendations on the following:
  - (1) The number of counseling staff in schools, which shall include a determination of how many of those persons are social workers, guidance counselors, nurses, nurse practitioners, physician assistants, and psychologists delineated by full-time and part-time staff equivalency and contractual staff equivalency or time allocation.
- 16 (2) The feasibility of staffing at least one social worker per school.

- (3) The feasibility of establishing certain educational programs or incentives to bring more mental health counselors into the workforce, which shall include counselors who have completed a dual degree program for mental health counseling and board-certified behavioral analysis and the like.
- (4) The potential effects of changing recommended guidelines for schools to specify that the recommended ratio applies exclusively to mental health professionals and not guidance counselors for academics.
- (5) The potential outcome of creating nurse advice lines to expand access to an initial source of non-emergency care, including for behavioral health, as part of the continuum of supports available for Medicaid beneficiaries.
- (6) Recommendations for initiatives to bolster guidance, oversight, and enforcement of existing laws to ensure those in the behavioral health workforce are reimbursed equitably when compared to their peers in the healthcare workforce, specifically regarding insurance reimbursement.

1 (7) Recommendations for initiatives to foster alignment among payors, through 2 public-private partnerships, to promote meaningful financial incentives and remove 3 administrative burdens, such as excessive paperwork and complex requirements for joining 4 health insurance networks and getting approvals from insurers as part of necessary care. 5 (8) Recommendations for incentives to encourage persons to enter the behavioral 6 health workforce in underserved areas, which shall include but not be limited to scholarships 7 and loan forgiveness. 8 (9) The pay and structural barriers to entering and remaining in the behavioral health 9 workforce, specifically for populations that are currently underrepresented, such as 10 educational practices that discourage participation by those that are socioeconomically 11 disadvantaged. 12 BE IT FURTHER RESOLVED that the Louisiana Department of Health shall 13 provide staff support to the task force. 14 BE IT FURTHER RESOLVED that the chairman and vice chairman of the task force 15 shall be elected by a majority of the task force members at its first meeting, which shall be 16 held no later than July 31, 2024. During the first meeting of the task force, its members may 17 select other officers as they deem appropriate. 18 BE IT FURTHER RESOLVED that the task force meetings shall be held monthly 19 and the final report of findings and policy recommendations from the task force shall be 20 submitted in the form of a written report to the House and Senate committees on health and 21 welfare no later than February 28, 2025. 22 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 23 president of the Louisiana School Psychologist Association, the president of the Louisiana 24 Association of School Social Workers, the chair of the Louisiana Commission on Civic 25 Education, the secretary of the Louisiana Department of Health, the Louisiana State 26 Superintendent of Education of the Louisiana Department of Education, the administrator 27 of the Louisiana State Board of Social Work Examiners, the president of the Louisiana 28 Counseling Association, the president of the Louisiana Association of Child Welfare and 29 Attendance, the president of the Louisiana State Nurses Association, the executive director of the Louisiana State Board of Examiners of Psychologists, the chair of the Louisiana 30
