HOUSE CONCURRENT RESOLUTION NO. 184

SCHOOLS/FINANCE-MFP: Requests the House and Senate education committees jointly to study issues relative to the MFP

1                                           A CONCURRENT RESOLUTION

2    To urge and request the House Committee on Education and the Senate Committee on

3           Education jointly to study issues relative to the minimum foundation program

4           formula and to submit a written report of findings and recommendations to the

5           Legislature of Louisiana not later than February 1, 2014.

6           WHEREAS, the minimum foundation program (MFP), required by the Constitution

7    of Louisiana, is the core of Louisiana's commitment to ensuring a minimum level of public

8    school funding; and

9           WHEREAS, in the 1990's the MFP changed from a cost-driven formula to one that

10   is primarily controlled by an anticipated appropriation, rather than an evaluation of the actual

11   costs of public education; and

12           WHEREAS, the MFP has been the subject of recent litigation, and there is confusion

13   over the purpose of the MFP and how the funding is intended to be used; and

14           WHEREAS, the MFP has been co-opted by other programs as a means of

15   determining charter school funding and online course provider funding, providing funds to

16   some nonpublic schools, and delivering certain state-mandated retirement funding; and

17           WHEREAS, there appears to be a lack of consistency in the understanding various

18   stakeholders have of the purpose and function of the MFP and the nature of the funding that

19   should be included within it; and

1           WHEREAS, the diversion of MFP dollars away from public school classrooms  
2 causes public confusion as to how much funding the state is really providing to the actual  
3 education of children.

4           THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
5 urge and request the House Committee on Education and Senate Committee on Education  
6 jointly to study issues relative to the minimum foundation program and to submit a written  
7 report of findings and recommendations to the Legislature of Louisiana not later than  
8 February 1, 2014.

9           BE IT FURTHER RESOLVED that in conducting the study the committees shall  
10 consider and review:

- 11           (1) The process by which the MFP is formulated.
- 12           (2) The factors that should be included in the MFP formula.
- 13           (3) The appropriateness of including retirement costs in the MFP.
- 14           (4) The nature and extent to which the development and adoption of the MFP should  
15 be subject to the Open Meetings Law and Public Records Law.
- 16           (5) The feasibility of reestablishing an MFP study commission and determining  
17 appropriate stakeholders to be included as members of such commission.

18           BE IT FURTHER RESOLVED that in conducting the study the committees shall  
19 invite the following stakeholders to provide information:

- 20           (1) The Louisiana School Boards Association.
- 21           (2) The Louisiana Association of School Superintendents.
- 22           (3) The Louisiana Association of School Executives.
- 23           (4) The Louisiana Association of Educators.
- 24           (5) The Louisiana Federation of Teachers.
- 25           (6) The Louisiana Association of Public Charter Schools.
- 26           (7) The Louisiana Department of Education.
- 27           (8) The State Board of Elementary and Secondary Education.
