HOUSE CONCURRENT RESOLUTION NO. 24

CHILDREN/SUPPORT: Suspends the implementation of provisions relative to the payment of child support during incarceration

1 A CONCURRENT RESOLUTION
2 To suspend until sixty days after final adjournment of the 2021 Regular Session of the
3 Legislature of Louisiana the effective date of Act No. 264 of the 2017 Regular
4 Session of the Legislature, as amended by Section 1 of Act No. 136 of the 2018
5 Regular Session of the Legislature and Section 2 of Act No. 277 of the 2019 Regular
6 Session of the Legislature, relative to the suspension of a child support order during
7 the obligor's incarceration.
8 WHEREAS, Act No. 264 of the 2017 Regular Session of the Legislature provides
9 for temporary suspension of a child support obligation owed by an obligor during his
10 incarceration; and
11 WHEREAS, Act No. 264 of the 2017 Regular Session of the Legislature requires the
12 Department of Children and Family Services to use departmental resources to administer and
13 implement the temporary suspension of a child support obligation owed by the obligor
14 during his incarceration; and
15 WHEREAS, Act No. 264 of the 2017 Regular Session of the Legislature called for
16 an effective date of August 1, 2018; and
17 WHEREAS, Section 1 of Act No. 136 of the 2018 Regular Session of the Legislature
18 extended the effective date of certain provisions of Act No. 264 of the 2017 Regular Session
19 of the Legislature to August 1, 2019; and

1 WHEREAS, Section 2 of Act No. 277 of the 2019 Regular Session of the Legislature
2 further extended the effective date of certain provisions of Act No. 264 of the 2017 Regular
3 Session of the Legislature to August 1, 2020; and

4 WHEREAS, the Department of Children and Family Services remains
5 administratively unprepared to implement the provisions of Act No. 264 of the 2017 Regular
6 Session of the Legislature and will benefit from suspension of the Act's effective date.

7 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana hereby suspends
8 the provisions of Act No. 264 of the 2017 Regular Session of the Legislature, as amended
9 by Section 1 of Act No. 136 of the 2018 Regular Session of the Legislature and Section 2
10 of Act No. 277 of the 2019 Regular Session of the Legislature.

11 BE IT FURTHER RESOLVED that this suspension shall become effective upon
12 adoption of this Resolution and shall extend through the sixtieth day after final adjournment
13 of the 2021 Regular Session of the Legislature of Louisiana.
