WHEREAS, Mr. Cryer also held membership in a variety of associations, including the American Institute of Certified Public Accountants, the Louisiana Society of Certified Public Accountants, and the Government Finance Officers Association; and

WHEREAS, during his tenure with the Louisiana Legislative Auditor's office, Bradley Cryer served in various capacities and positions; from 1996-2008, he worked as a staff and senior auditor in financial audit services; from 2008-2010, he served as manager of financial audit services; from 2010-2016, he served as the assistant director of financial audit services; and from 2016 until his passing, he served as an assistant legislative auditor and director of local government services; and
