A CONCURRENT RESOLUTION

To recognize the bicentennial of Louisiana's statehood and to encourage participation in local and statewide bicentennial observances and activities.

WHEREAS, it is appropriate to commemorate the bicentennial of the statehood of Louisiana as the state's unique history and heritage are recognized and celebrated; and

WHEREAS, 2012 marks the two hundredth anniversary of Louisiana's attainment of statehood upon its admission by congress as the eighteenth state in the union on April 30, 1812; and

WHEREAS, throughout the state, this memorable and historic anniversary is being marked by ceremony and celebration as well as scholarship and education; and

WHEREAS, in 1811, President James Madison signed the bill allowing the people of Louisiana to form a state constitution, and following the state constitutional convention in New Orleans, where forty-three American and Creole leaders convened, President

Madison signed the bill approving statehood on April 14, 1812, designating April 30, 1812,

as the day of formal admission; and

WHEREAS, Louisiana was the first state to have a majority Catholic French- and

Spanish-speaking population, reflecting its origins as a colony under France from 1699-1763

and Spain from 1763-1803; and

WHEREAS, two hundred years after statehood, Louisiana remains one of the most

distinctive states in the union; and

WHEREAS, the bicentennial of Louisiana merits special recognition, for it celebrates

the tremendous pride and honor that the state has brought to the nation for the past two

centuries with its uniquely rich history and culture.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby

recognize the bicentennial of the statehood of Louisiana, does hereby commend the citizens

of Louisiana, past and present, for their extraordinary contributions to the Pelican State, and

does hereby record the singular place that the state of Louisiana holds in the history and

future of the United States of America.

BE IT FURTHER RESOLVED that the legislature does hereby encourage

participation in local and statewide bicentennial observances and activities.
