TAX/TAX REBATES: Suspends the authority of the secretary of the Department of Revenue to enter into new contracts or renewals of existing contracts pursuant to the Procurement Processing Company Rebate Program (Item #65)

A CONCURRENT RESOLUTION

2	To suspend until sixty days after final adjournment of the 2021 Regular Session of the
3	Legislature of Louisiana the authority of the secretary of the Department of Revenue
4	to enter into new contracts or to renew existing contracts with a procurement
5	processing company as provided for in R.S. 47:6351(B)(1) pursuant to the
6	Procurement Processing Company Rebate Program.
7	WHEREAS, R.S. 47:6351(B)(1) authorizes the secretary of the Department of
8	Revenue to enter into a contract with a procurement processing company to recruit to
9	Louisiana purchasing companies that generate sales of items subject to state taxes that would
10	also have a significant positive economic benefit to this state; and
11	WHEREAS, R.S. 47:6351(B)(1) prohibits the initial term of a contract from
12	exceeding twenty years and shall be renewable for an additional twenty years; and
13	WHEREAS, since this incentive was established in 2012, it is not the intent of this
14	Resolution to interfere with existing contracts; however, the suspension provided for in this
15	Resolution shall apply to new contracts or to the renewal of existing contracts during the
16	period of the suspension.
17	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana hereby suspends
18	the authority of the secretary of the Department of Revenue to enter into new contracts or
19	to renew existing contracts with a procurement processing company as provided for in R.S.
20	47:6351(B)(1) pursuant to the Procurement Processing Company Rebate Program.

- BE IT FURTHER RESOLVED that this suspension shall become effective upon
- 2 adoption of this Resolution and shall extend through the sixtieth day after final adjournment
- 3 of the 2021 Regular Session of the Legislature of Louisiana.
