WHEREAS, throughout his prominent military career, Staff Sergeant Bergeron was deployed in Support of Operation Iraqi Freedom as a UH-60 Helicopter Repairer; and

WHEREAS, Staff Sergeant Bergeron served in the Louisiana Army National Guard with great courage and valor as evidenced by his receipt of numerous awards and decorations, some of which include the Meritorious Service Medal, the Air Medal, the Army Commendation Medal, the Army Good Conduct Medal, the National Defense Service Medal with Bronze Star, the Senior Aviation Badge, the Combat Action Badge, the Louisiana War Cross, the Louisiana Emergency Service Medal, the Louisiana General Excellence Ribbon, and the Louisiana Longevity Ribbon; and

WHEREAS, Staff Sergeant Bergeron was a brother, son, and friend to many and a hero to all; and
