#### HOUSE CONCURRENT RESOLUTION NO. 7

#### BY REPRESENTATIVE STOKES

TAX/SALES & USE: Establishes the Sales Tax Streamlining and Modernization Commission, as the successor to the commission established by Act No. 405 of the 2015 Regular Session of the Legislature, to continue the comprehensive study of Louisiana's state and local sales and use tax systems

2	To establish the Sales Tax Streamlining and Modernization Commission, as the successor		
3	to the commission established by Act No. 405 of the 2015 Regular Session of the		
4	Legislature, to continue the comprehensive study of Louisiana's state and local sales		
5	and use tax systems.		
6	WHEREAS, the statutory authority for the Sales Tax Streamlining and		
7	Modernization Commission established by Act No. 405 of the 2015 Regular Session of the		
8	Legislature terminates on June 30, 2018; and		
9	WHEREAS, the sales and use taxes on tangible personal property, services, rentals,		
10	and leases, hereinafter referred to as "sales tax", represent one of Louisiana's two major		
11	revenue sources and provide a substantial portion of state general fund receipts, and sales		
12	tax is the main source of revenue for most of Louisiana's local governments; and		
13	WHEREAS, the average combined sales tax rate of 10.02% for Louisiana was the		
14	highest in the nation as reported by the Tax Foundation in 2018; and		
15	WHEREAS, there exist significant structural issues impacting the state and local		
16	sales taxes, which include legislative actions that adversely impact the tax base, a distinct		
17	shift away from a goods-based to a services-based economy, and an increasing shift from		
18	"brick and mortar" retail transactions to e-commerce purchases; and		
19	WHEREAS, the legislature recognizes that it is good public policy to contemplate		
20	modernization of the sales tax structure to reflect the twenty-first century economy as a way		

1 to aid in stabilizing the sales tax as a revenue source for the state and its local governments; 2 and

3 WHEREAS, the recent United States Supreme Court decision in South Dakota v. 4 Wayfair, Inc., et al. on June 21, 2018, regarding South Dakota's requirements for certain 5 out-of-state sellers to collect and remit sales taxes in the same manner as if the seller had a 6 physical presence in the state necessitates further examination of Louisiana's state and local 7 sales tax structure.

8 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 9 create the Sales Tax Streamlining and Modernization Commission, hereinafter referred to 10 as "commission", as the successor commission to the commission established by Act No. 11 405 of the 2015 Regular Session of the Legislature, to continue the comprehensive study of 12 Louisiana's state and local sales tax systems, and to make recommendations to the legislature 13 regarding revision of practices, administrative procedure, statutory law, and the Constitution 14 of Louisiana, all for the purpose of streamlining and modernizing the vital sales tax revenue 15 source for the state and its local governments.

16 BE IT FURTHER RESOLVED that the commission's recommendations shall 17 encompass an overall goal of ensuring both revenue stability and taxpayer equity through 18 the adoption of proven contemporary tax policies.

19 BE IT FURTHER RESOLVED that the commission shall consist of the following 20 members:

- 21 (1) The speaker of the House of Representatives or his designee.
- 22 (2) The president of the Senate or his designee.
- 23 (3) The chairman of the House Committee on Ways and Means or his designee.
- 24 (4) The chairman of the Senate Committee on Revenue and Fiscal Affairs or his 25
  - designee.
- 26 (5) A member appointed by the Police Jury Association of Louisiana.
- 27 (6) A member appointed by the Louisiana Municipal Association.
- 28 (7) A member appointed by the Louisiana School Boards Association.
- 29 (8) A member appointed by the Louisiana Association of Tax Administrators.
- 30 (9) A member appointed by the Louisiana Sheriffs Association.

13	BE IT FURTHER RESOLVED that the members of the commission shall serve		
14	without compensation except for reasonable and necessary expenses related to the		
15	performance of their duties as members of the commission, and then only in such amounts		
16	as is provided by law for state employees and officials, or per diem or expense		
17	reimbursement to which they may be individually entitled as members of their constituent		
18	organizations.		
19	BE IT FURTHER RESOLVED that the commission shall conduct meetings as		
20	necessary to fulfill it's functions and duties.		
21	BE IT FURTHER RESOLVED that the chairman of the commission established by		
22	Act No. 405 of the 2015 Regular Session of the Legislature shall convene the first meeting		
23	of the commission and at that meeting, the commission shall elect a chairman and a vice		
24	chairman and any other officers it deems necessary.		
25	BE IT FURTHER RESOLVED that the following organizations shall assist the		
26	commission with staff support as may be required:		
27	(1) The Department of Revenue.		
28	(2) The House of Representatives, Senate, Legislative Fiscal Office, and Legislative		
29	Auditor's Office.		

# 1 BE IT FURTHER RESOLVED that the commission shall submit its report of

2 recommendations to the governor, the president of the Senate, and the speaker of the House

3 of Representatives no later than March 15, 2019, and may submit additional reports as it

4 deems necessary.

5 BE IT FURTHER RESOLVED that the commission shall terminate on July 1, 2019.

6 BE IT FURTHER RESOLVED that a copy of this resolution be transmitted to each

7 appointing authority.

- (2) The president of the Senate or his designee.
- (3) The chairman of the House Ways and Means Committee or his designee.
- (4) The chairman of the Senate Revenue and Fiscal Affairs Committee or his designee.
- (5) A member appointed by the Police Jury Assoc. of La.
- (6) A member appointed by the La. Municipal Assoc.
- (7) A member appointed by the La. School Boards Assoc.
- (8) A member appointed by the La. Assoc. of Tax Administrators.
- (9) A member appointed by the La. Sheriffs Assoc.
- (10) A member appointed by the La. Multiparish Tax Commission.
- (11) A member appointed by LABI.
- (12) A member appointed by the La. Retailers Assoc.
- (13) A member appointed by the La. Automobile Dealers Assoc.
- (14) A member appointed by National Federation of Independent Businesses.
- (15) A member appointed by La. Industrial Development Executives Assoc.
- (16) A member appointed by Society of La. Certified Public Accountants.
- (17) A member appointed by the PAR.
- (18) A member appointed by the Tax Foundation.
- (19) The secretary of the Dept. of Revenue or his designee.
- (20) The legislative auditor or his designee.

Provides that the members of the commission serve without compensation except for reasonable and necessary expenses related to the performance of duties as members of the commission, and then only in such amounts as is provided by law for state employees and officials, or per diem or expense reimbursement to which they may be individually entitled as members of their constituent organizations.

Provides that the commission shall submit its report of recommendations to the governor, the president of the Senate, and the speaker of the House of Representatives no later than March 15, 2019, may submit additional reports as it deems necessary, and shall terminate on July 1, 2019.
