| 8 | WHEREAS, these provisions can be termed "miscellaneous" only by virtue of their | | |
| 9 | inclusion within a single chapter of law; and | | |
| 10 | WHEREAS, this chapter of law is no longer organized in an intentional manner; and | | |
| 11 | WHEREAS, the absence of a logical system of order in this chapter perpetuates the | | |
| 12 | problem of disorganization in an area of law that has come to encompass many high-profile | | |
| 13 | and frequently revised statutes. | | |
