CONDOLENCES: Expresses condolences upon the deaths of the eleven men killed in the Deepwater Horizon explosion on April 20, 2010

A RESOLUTION

2 To express sincere and heartfelt condolences upon the deaths of Jason Anderson, Aaron 3 Dale Burkeen, Donald Clark, Stephen Curtis, Roy Wyatt Kemp, Karl Kleppinger, Jr., 4 Gordon Jones, Blair Manuel, Dewey Revette, Shane Roshto, and Adam Weise, who 5 lost their lives in the Deepwater Horizon explosion on April 20, 2010. 6 WHEREAS, it was with profound shock and sorrow that the members of the 7 Louisiana House of Representatives learned of the tragic deaths of Jason Anderson, Aaron 8 Dale Burkeen, Donald Clark, Stephen Curtis, Roy Wyatt Kemp, Karl Kleppinger, Jr., 9 Gordon Jones, Blair Manuel, Dewey Revette, Shane Roshto, and Adam Weise, who were 10 killed in the explosion of the Deepwater Horizon drilling rig on April 20, 2010; and 11 WHEREAS, Jason Anderson was born on November 22, 1974, in Freeport, Texas, 12 the son of Billy Fred Anderson and Darlene White and the younger brother of Stephanie 13 Kathleen; he was a middle linebacker for the Tidehaven High School football team, attended 14 Wharton County Junior College, and went into the oil field business, excelling at his job and 15 receiving numerous promotions; he married his soulmate, Shelley Simons Anderson, in 16 2002, and in recent years, they lived in Midfield, Texas, with their two children, Lacy 17 Kathleen and Ryver Clay; a member of Midfield Community Church, he was fun-loving, 18 spontaneous, and known for his Texas two-step, and he enjoyed hunting, golfing, and 19 traveling with his family in their motor home; he is survived by his wife, children, parents, 20 brother, Jacob Ryne, numerous other family members, and friends who were like brothers 21 to him; and

1	WHEREAS, Aaron Dale Burkeen of Philadelphia, Mississippi, was born on April
2	24, 1972, was a loving husband, a committed father of two, the brother of two sisters, and
3	the son of proud parents; he attended Neshoba Central High School and East Central
4	Community College, was a crane operator who worked for Transocean for ten years, and
5	was an avid deer hunter and fisherman; his survivors include his wife, Rhonda Burkeen, his
6	parents, Mary Bryan Burkeen and Roger Burkeen, his daughter, Aryn Sydney Burkeen, his
7	son, Timothy Dale Burkeen, his sisters, and his nieces, nephews, aunts, uncles, and cousins;
8	and
9	WHEREAS, Donald Clark of Newellton, Louisiana, was a soybean farmer like his
10	father before going to work on the Deepwater Horizon rig; he was a dedicated worker, a
11	family man, a fisherman, and a Christian who devoted his life to his beloved wife, Sheila,
12	and four children; and he was known throughout his community for his good heart, his
13	calmness, his smile, and for always being willing to lend a helping hand; and
14	WHEREAS, Stephen Curtis was a 1987 graduate of Georgetown High School in
15	Grant Parish, Louisiana, and is survived by his wife, Nancy, his son and daughter, his
16	granddaughter, and his parents, Howard and Betty Sharp Curtis; active in his church, he was
17	a Christian who taught a Bible class with his wife, and he participated in a Bible study on
18	the rig; and he was a proud Marine and a volunteer firefighter and had been in the oil
19	business for seventeen years; and
20	WHEREAS, Gordon Jones of Baton Rouge, Louisiana, was born on June 26, 1981,
21	and was a loving husband, father, son, and brother; he was a graduate of St. Aloysius
22	Catholic School, Catholic High School, and Louisiana State University; he was a friend to
23	all, enjoyed spending time with his family, was an excellent golfer and joke teller, and loved
24	to laugh; he is survived by his wife, Michelle Mummert Jones, his sons, Stafford Hess Jones
25	and Maxwell Gordon Jones, who were born the month after his father died, his mother,
26	Eilleen Kean Jones, his father, Keith Dunn Jones, his brother, his sister, his grandparents,
27	and numerous other relatives, nieces, nephews, and friends; and
28	WHEREAS, Roy Wyatt Kemp was born on January 21, 1983, in Ferriday, Louisiana,
29	to Peggy Kemp and the late Sandy Lee Kemp, was a resident of Jonesville, Louisiana, and
30	was a member of Pleasant Grove Baptist Church in Jonesville; he was a devoted husband,

1 father, son, and grandson, but most of all he was a man who loved the Lord; an avid 2 fisherman and hunter who served in the Army for a time, he had a unique sense of humor 3 and loved the outdoors and spending time with his family, friends, hunting dog Ellie, and 4 fellow crewmen of the Deepwater Horizon; and he is survived by his wife and best friend, 5 Courtney Carpenter Kemp, his children, Kaylee Joyce Kemp and Clara Maddison Kemp, his 6 mother, Peggy Kemp, his brother and sisters and their spouses, his grandparents and great-7 grandmother, his in-laws, and numerous nieces, nephews, aunts, uncles, cousins, and friends; 8 and 9 WHEREAS, Karl Kleppinger, Jr., was born on August 21, 1971, in Baton Rouge, 10 Louisiana, was a beloved husband and father, and was a United States Army veteran of 11 Operation Desert Storm; he was a family man who enjoyed watching NASCAR and cooking 12 barbeque, was employed by Transocean for ten years, and considered his crewmates on the 13 Deepwater Horizon his second family; and his survivors include his wife, Tracy Kleppinger, 14 his son, Aaron Kleppinger, his parents, Karl Dale Kleppinger, Sr., and Jo Ann Kleppinger, 15 two sisters, two brothers, his grandmother, Barbara Thornhill, his in-laws, and a number of 16 aunts, uncles, cousins, nieces, and nephews; and 17 WHEREAS, Blair Manuel was a native of Eunice, Louisiana, and a resident of St. 18 Amant, Louisiana, attended St. Edmund's Elementary School and Eunice High School, and 19 was very active in his community, serving as a member of the St. Anthony of Padua Parish 20 Council and as president of the Eunice Jaycees; he loved spending time with his fiancee, 21 family, and friends, hunting and fishing, white water rafting, traveling, gardening, and 22 attending LSU football and baseball games as an avid fan and season ticket holder; he had 23 a winning smile and a compassionate heart and is survived by his parents, L.D. and Geneva 24 Manuel, his beloved fiancee, Melinda Becnel, three daughters, Kelli Manuel Taquino, 25 Jessica Manuel Manchester, and Ashley Jo Manuel, his sister, and his brothers; and 26 WHEREAS, Dewey Revette was born on May 27, 1961, to Arthur Dewey Revette, 27 Jr., and Katherine Revette and was a native of Waynesboro, Mississippi, and a resident of 28 State Line, Mississippi; he had been with the Transocean drilling company for twenty-nine 29 years and was a highly skilled driller; a widely respected and admired gentleman, he is

6	loved his job, was ambitious, and had a strong work ethic and wrote the dates of his wedding
7	day and his son's birthday inside his hard hat; and he is survived by his wife, Natalie, his
8	three-year-old son, Blaine Michael, his mother, Denise, his stepfather, Bobby Arnold, his
9	father and stepmother, Ronnie and Debbie Roshto, his sister and brother, his nieces and
10	nephews, his grandparents, his in-laws, and numerous co-workers and friends; and
11	WHEREAS, Adam Weise of Yorktown, Texas, was born in Cuero on January 19,
12	1986, and was a 2005 graduate of Yorktown High School, where he played football, received
13	Second Team All-District honors, and was named one of the Wildcats' outstanding linemen;
14	an avid hunter and fisherman who was honest, hardworking, joyful, good with children, and
15	a great friend, he is survived by his grandmother, Nelda Winslette, his mother, Arleen
16	Weise, his brother, Christopher Weise, his sisters, Gwen Weise and Sara Weise, his
17	girlfriend, Cindy Shelton, and his nephews, nieces, aunts, uncles, cousins, and friends; and
18	WHEREAS, mere words cannot begin to express the depths of the tremendous void
19	that the deaths of these men have left in the lives of their families and friends, and their
20	passings have created a genuine sense of grief and loss in the hearts of their fellow citizens;

22	WHEREAS, with the deaths of these individuals, their families, friends, and fellow
23	citizens have lost men whose contributions have left an indelible mark on every person
24	whose life they touched; and
25	WHEREAS, these gentlemen deserve honor, recognition, gratitude, and respect for
26	the joy that they brought to their family, friends, communities, states, and nation.
27	THEREFORE, BE IT RESOLVED that the House of Representatives of the
28	Legislature of Louisiana does hereby express sincere condolences upon the deaths of Jason
29	Anderson, Aaron Dale Burkeen, Donald Clark, Stephen Curtis, Roy Wyatt Kemp, Karl
