A RESOLUTION

2 To urge and request the State Board of Elementary and Secondary Education to adopt a 3 policy prohibiting teachers from discussing their sexual orientation or gender identity 4 with students and requiring them to limit classroom discussions to those topics 5 included in the state content standards approved by the state board and in textbooks 6 and other instructional materials approved by the local public school board. 7 WHEREAS, the Constitution of Louisiana states that the goal of the public 8 educational system is to provide learning environments and experiences, at all stages of 9 human development, that are humane, just, and designed to promote excellence in order that 10 every individual may be afforded an equal opportunity to develop to his full potential; and 11 WHEREAS, the constitution further provides that the legislature shall provide for the 12 education of the people of the state and shall establish and maintain a public educational 13 system; and 14 WHEREAS, in order to maximize each student's opportunity to develop to his full 15 potential, succeed in school, and become productive members of society, it is important that 16 teachers focus classroom discussions on approved educational matters and not discuss the 17 private details of their personal lives with students. 18 THEREFORE, BE IT RESOLVED that the House of Representatives of the 19 Legislature of Louisiana does hereby urge and request the State Board of Elementary and 20 Secondary Education to adopt a policy prohibiting teachers from discussing their sexual HLS 22RS-4804 ORIGINAL HR NO. 169
