## A RESOLUTION

To commend First Sergeant Lindsey Duplechain Halley upon her retirement from the U.S.

WHEREAS, Sergeant Halley served two tours of duty in Kuwait/Iraq in support of Operation Iraqi Freedom and was mobilized in support of Operation Enduring Freedom, Ft. Sill, Oklahoma, and ordered to active duty in support of Operation Desert Shield/Desert Storm, Ft. Bliss, Texas; and

WHEREAS, in addition to her involvement with the nation's overseas military actions, Sergeant Halley served with distinction in a large number of assignments and positions of significant leadership including Acting Financial Management Center Sergeant Major, Financial Management Advisor, 469th Financial Management Center, New Orleans, Louisiana; Financial Management Auditor, Internal Control Team Non-Commissioned Officer In Charge, Balad, Iraq and Camp Arifjan, Kuwait; Disbursing Agent, Finance Non-Commissioned Officer in Charge, and Detachment Sergeant, Camp Bucca, Iraq, 1/376th, Wausau, Wisconsin; Personal Service Manager, S-1 Non-Commissioned Officer In Charge, Camp Arifjan Kuwait; Course Manager, Senior Instructor and Small Group Leader, Baton Rouge, Louisiana and Oklahoma City, Oklahoma; First Sergeant, 294th
