

1 WHEREAS, according to information from the state Department of Education, only
2 about twenty-eight percent of students identified as gifted are economically disadvantaged
3 and only eighteen percent of the gifted student population are students of color; and

4 WHEREAS, current law (R.S. 17:7(11)) requires the State Board of Elementary and
5 Secondary Education to adopt and provide for the implementation of a program for students
6 enrolling in public schools to be tested for dyslexia and related disorders as may be
7 necessary; and

8 WHEREAS, current law (R.S. 17:392.1) requires that every child in public school
9 in kindergarten through grade three be screened for the existence of impediments to a
10 successful school experience including dyslexia and related disorders; and

11 WHEREAS, state law defines "dyslexia" as a language processing disorder that may
12 be manifested in difficulties with reading, comprehension, writing, and spelling, despite
13 adequate intelligence, educational exposure, and cultural opportunity; and

14 WHEREAS, pursuant to state law, the State Board of Elementary and Secondary
15 Education adopted regulations, as contained in *Bulletin 1903—Regulations for the*
16 *Implementation of Louisiana Law for the Education of Dyslexic Students*, to require school
17 systems to identify, evaluate, and support students with dyslexia; and

18 WHEREAS, current law, R.S. 17:182, requires the governing authority of each
19 public elementary school to implement a reading program that is designed and intended to
20 teach each student to read at grade level by the end of the first grade; and

21 WHEREAS, this law further requires each second grade teacher and each third grade
22 teacher to report the number of students in the teacher's class who cannot read at grade level
23 and requires that this information be sent to the state superintendent of education and the
24 State Board of Elementary and Secondary Education; and

25 WHEREAS, the law additionally requires the State Board of Elementary and
26 Secondary Education annually to compile a report of such information for each school,
27 school system, and the state as a whole and to submit the report to the House and Senate
28 education committees; and

1 WHEREAS, one way to increase equity in the identification of students who are
2 gifted and those who have dyslexia is to consider the results of screenings administered to
3 elementary school students; and

4 WHEREAS, this information could reveal individual student abilities and challenges
5 that suggest the need for a student to be evaluated to determine if he is gifted or dyslexic or
6 both.

7 THEREFORE, BE IT RESOLVED that the House of Representatives of the
8 Legislature of Louisiana does hereby urge and request each public school governing
9 authority to review and consider the results of student screenings conducted to determine
10 whether a student should be evaluated for dyslexia or giftedness, or both, in accordance with
11 state laws and regulations.

12 BE IT FURTHER RESOLVED that the House of Representatives of the Legislature
13 of Louisiana does hereby urge and request each public school governing authority to study
14 the feasibility of implementing universal screenings of students for dyslexia and giftedness
15 in order to provide all students with an equal opportunity to have their needs identified and
16 properly supported so that they may develop to their full potential.

17 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
18 executive directors of the Louisiana Association of School Superintendents, the Louisiana
19 School Boards Association, and the Louisiana Association of Public Charter Schools, the
20 president of the State Board of Elementary and Secondary Education, and the state
21 superintendent of education.
