1 A RESOLUTION

2 To express the condolences of the Louisiana House of Representatives upon the tragic death  
3 of Natasha Maria Hunter, a New Orleans Police Department officer.

4 WHEREAS, it was with deep regret and profound sorrow that the members of the  
5 Louisiana House of Representatives learned of the death of Natasha Maria Hunter, a New  
6 Orleans Police Department officer, on Tuesday, June 7, 2016, at the age of thirty-two; and

7 WHEREAS, Ms. Hunter was a twelve-year veteran of the New Orleans Police  
8 Department and was highly committed to serving and protecting the community, the ideal  
9 of what a police officer should be; and

10 WHEREAS, she was a dedicated public servant who truly loved her job and her  
11 family; and

12 WHEREAS, the officers of the New Orleans Police Department deeply mourn the  
13 death of Ms. Hunter; she will forever be remembered for her ceaseless courage and concern  
14 for others; and

15 WHEREAS, she is survived by her parents, Linda Hunter Sherman and Nathaniel S.  
16 Sherman; her daughter, Jasmine Maria Hunter; her grandparents, Icola Hunter and Nathaniel  
17 and Lillian Sherman; her sisters, Nishe Caire and her husband James, Ayanna Hunter Davis  
18 and her husband Terrence, Sr., Oran Perrier, Sonya Pollard and her husband Brian, Kianka  
19 Hunter Harris and her husband Damond, Jacquen Hunter and her husband Frederick,

2 nephews, other relatives, and friends; and

3 WHEREAS, she was preceded in death by her grandfather, Edward Hunter, Sr.; and
