MOTOR VEHICLES: Creates the Wireless Telecommunications and Vehicle Safety Study Commission to study the use of a wireless telecommunications device while operating a motor vehicle

A RESOLUTION

2	To create and establish the Wireless Telecommunications and Vehicle Safety Study
3	Commission to study the use of a wireless telecommunications device while
4	operating a motor vehicle.
5	WHEREAS, the use of wireless telecommunications devices while operating a motor
6	vehicle is becoming an epidemic within the state of Louisiana; and
7	WHEREAS, using a wireless telecommunications device while operating a vehicle
8	is one of the top distractions for drivers traversing the roadways throughout the country; and
9	WHEREAS, a person cannot travel on any road within this state without noticing
10	someone using a wireless telecommunications device while operating a motor vehicle; and
11	WHEREAS, numerous accidents, including fatalities, have occurred due to people
12	being distracted while driving using their wireless telecommunications device while
13	operating a motor vehicle; and
14	WHEREAS, House Bill No. 229 of the 2019 Regular Session proposed regulating
15	the use of a wireless telecommunications device while operating a motor vehicle; and
16	WHEREAS, if enacted, House Bill No. 229 would have provided for changes and
17	additions to current provisions of law regulating the use of a wireless telecommunications
18	device while operating a motor vehicle; and

2	necessary changes and addition to current provisions regulating the use of a wireless
3	telecommunications device while operating a motor vehicle.
4	THEREFORE, BE IT RESOLVED that the House of Representatives of the
5	Legislature of Louisiana does hereby create the Wireless Telecommunications and Vehicle
6	Safety Study Commission to study the use of a wireless telecommunications device while
7	operating a motor vehicle and provide recommendations for changes and additions to current
8	provisions of law regulating the use of a wireless telecommunications device while operating
9	a motor vehicle.
10	BE IT FURTHER RESOLVED that the study commission shall be composed of the
11	following members:
12	(1) The secretary of the Department of Public Safety and Corrections or his
13	designee.
14	(2) A representative of the Department of Public Safety and Corrections, office of
15	state police as appointed by the superintendent.
16	(3) The president of the Louisiana Sheriffs' Association or his designee.
17	(4) The president of the Louisiana Association of Chiefs of Police or his designee
18	(5) The chief executive officer of StopDistractions.org or his designee.
19	BE IT FURTHER RESOLVED, at a minimum, the commission shall study the
20	following:
21	(1) The magnitude of the problem.
22	(2) Crash types involving the use of a wireless telecommunications device while
23	operating a motor vehicle, whether fatal or non-fatal, single vehicle or multiple vehicle, and
24	the age of the people or person involved.
25	(3) Contrast crash types involving the use of a wireless telecommunications device
26	while driving as opposed to crash types that do not involve the use of a wireless
27	telecommunications device while driving.
28	(4) Strategies that have the potential for reducing the use of a wireless
29	telecommunications device while operating a motor vehicle.

WHEREAS, further inquiry and investigation is necessary to fully develop the

- 4 BE IT FURTHER RESOLVED that the Wireless Telecommunication and Vehicle
- 5 Safety Study Commission shall cease on February 28, 2020.
- 6 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 7 secretary of the Department of Public Safety and Corrections, the superintendent of the
- 8 Department of Public Safety and Corrections, office of state police, the president of the
- 9 Louisiana Sheriffs' Association, the president of the Louisiana Association of Chiefs of
- Police, and the chief executive officer of StopDistractions.org.

Creates the Wireless Telecommunications and Vehicle Safety Study Commission to study the use of a wireless telecommunications device while operating a motor vehicle.

Provides that the commission be comprised of the following: the secretary of the Dept. of Public Safety and Corrections or his designee, a representative of the Dept. of Public Safety and Corrections, office of state police, as designated by the superintendent, the president of the Louisiana Sheriffs' Association or his designee, the president of the Louisiana Association of Chiefs of Police or his designee, and the chief executive officer of StopDistractions.org or his designee.

Requires the commission study the following: the magnitude of the problem; crash types involving the use of a wireless telecommunications device while operating a motor vehicle, whether fatal or non-fatal, single vehicle or multiple vehicle, and the age of the people or person involved; contrast crash types involving the use of a wireless telecommunications device while driving as opposed to crash types that do not involve the use of a wireless telecommunications device while driving; and strategies that have the potential for reducing the use of a wireless telecommunications device while operating a motor vehicle.

Requires the commission to submit a report detailing the results of its study and its recommendations to the legislature prior to Feb. 1, 2020.
