HOUSE RESOLUTION NO. 32

APPROPRIATIONS: Requests the Louisiana Legislature to prioritize spending monies received by the state from the American Rescue Plan Act of 2021 on certain existing obligations

1	A RESOLUTION
2	To urge and request the Louisiana Legislature to prioritize spending the state portion of
3	monies received pursuant to the American Rescue Plan Act of 2021 (P.L. 117-2) in
4	a strategic manner on certain key state obligations.
5	WHEREAS, earlier this year, in response to the COVID-19 pandemic that continues
6	to disrupt daily life for millions of Americans, congress passed the American Rescue Plan
7	Act of 2021 (P.L. 117-2); and
8	WHEREAS, the American Rescue Plan Act of 2021 is a multi-trillion dollar package
9	of relief legislation that will send billions of dollars directly to states and local governments
10	for COVID-relief efforts; and
11	WHEREAS, Louisiana anticipates receiving \$3.2 billion from this Act which the Act
12	dedicated for costs incurred to respond to the COVID-19 health emergency, to supplement
13	incomes of eligible workers; to provide government services; and to make necessary
14	investments in water, sewer, or broadband infrastructure; and
15	WHEREAS, Louisiana faces multiple sizeable expenditures in the next several years,
16	including infusing capital into a completely depleted Unemployment Compensation Fund
17	and liquidating a steadily increasing loan balance with the Federal government in order to
18	continue paying unemployment benefits to eligible recipients; an outstanding debt of over
19	\$1 billion to the federal government for the Hurricane and Storm Drainage Risk Reduction
20	System; and required debt defeasance payments on over \$7 billion in state debt; and

- 1 WHEREAS, despite these looming and potentially devastating payments, Louisiana
- 2 is in a fortunate position in that it is scheduled to receive an unprecedented amount of federal
- 3 dollars at a time when it is facing crippling expenditures.
- 4 THEREFORE, BE IT RESOLVED that the House of Representatives of the
- 5 Legislature of Louisiana does hereby declare that it is a priority to spend monies allocated
- 6 to the state by the American Rescue Plan Act of 2021 in a responsible manner and further
- 7 urges and requests the full legislature to prioritize spending these monies on shoring up the
- 8 state's Unemployment Compensation Fund, making payments on the Hurricane and Storm
- 9 Drainage Risk Reduction System, and liquidating outstanding state debt obligations.
