SPECIAL DAY/WEEK/MONTH: Recognizes March 22, 2018, as the thirty-fourth annual Red and White Day at the Louisiana Legislature

A RESOLUTION

2	To recognize Thursday, March 22, 2018, as the thirty-fourth annual Red and White Day at
3	the Louisiana Legislature.
4	WHEREAS, the celebration of Red and White Day at the Louisiana Legislature
5	began in 1985 and has grown from a Louisiana tradition to one observed by more than one
6	thousand sorority and fraternity chapters throughout the country; a celebration is held
7	annually at the nation's capital in Washington, D.C.; and
8	WHEREAS, Red and White Day is an activity of Delta Sigma Theta Sorority,
9	Incorporated, which was founded on January 13, 1913, by twenty-two collegiate women at
10	Howard University who were eager to use their collective strength to promote academic
11	excellence; and
12	WHEREAS, Delta Sigma Theta Sorority, Incorporated, was organized to provide
13	scholarships and support to those in need, to educate and stimulate participation in the
14	establishment of positive public policy, to highlight issues, and to find solutions to problems
15	in their communities; and
16	WHEREAS, Delta Sigma Theta Sorority was incorporated in 1930 as a private,
17	nonprofit organization to provide assistance through established programs in local
18	communities and throughout the world; and

1	WHEREAS, Delta Sigma Theta Sorority, Incorporated, is the largest African
2	American Greek letter sorority and is composed of more than two hundred thousand
3	predominately African American college-educated women; and
4	WHEREAS, Delta Sigma Theta Sorority, Incorporated, has more than nine hundred
5	chapters in the United States, England, Japan, Germany, the Virgin Islands, Bermuda, Haiti,
6	the Bahamas, and the Republic of Korea; and
7	WHEREAS, Delta Sigma Theta Sorority, Incorporated, uses a five-point program
8	of economic development, educational development, international awareness and
9	involvement, physical and mental health, and political awareness and involvement to assist
10	the global community; and
11	WHEREAS, represented in the ranks of Delta Sigma Theta Sorority, Incorporated,
12	are such notable women as former state senators Diana E. Bajoie and Cheryl Gray Evans,
13	former state representatives Renee Gill Pratt, Pinkie Carolyn Wilkerson, Rosalind Peychaud,
14	and Jalila Jefferson Bullock, and Senator Karen Carter Peterson, all of whom have left
15	indelible imprints on this state's history; and
16	WHEREAS, on this Red and White Day, the sorority honors and celebrates all of the
17	African American female legislators serving the public, and who make a major impact on
18	their respective communities and the state by championing important issues; and
19	WHEREAS, Deborah Elam, the first African American female corporate officer for
20	General Electric and a dedicated member of Delta Sigma Theta Sorority, Incorporated, will
21	serve as the keynote Red and White Day speaker; and
22	WHEREAS, it is appropriate to commend Delta Sigma Theta Sorority, Incorporated,
23	on one hundred five years of service and for its outstanding achievements in the community,
24	the state, and the world.
25	THEREFORE, BE IT RESOLVED that the House of Representatives of the
26	Legislature of Louisiana does hereby recognize Thursday, March 22, 2018, as Red and
27	White Day at the Louisiana Legislature; does hereby commend the women of Delta Sigma
28	Theta Sorority, Incorporated, for their exceptional achievements and manifold contributions;
29	and does hereby extend enduring appreciation to the organization and its members for the
