UNEMPLOYMENT COMP: Requests the House Committee on Labor and Industrial Relations to study increasing unemployment compensation amounts and expanding unemployment compensation eligibility

A RESOLUTION

2	To urge and request the House Committee on Labor and Industrial Relations to study the
3	feasibility of increasing unemployment compensation amounts and expanding
4	unemployment compensation eligibility.
5	WHEREAS, the neighboring states of Texas, Arkansas, Georgia, and Alabama all
6	have a lower cost of living and higher maximum unemployment compensation benefits than
7	the state of Louisiana; and
8	WHEREAS, Louisiana pays the third lowest of average weekly benefits amounts of
9	any state in the United States; and
10	WHEREAS, the average rent price in Louisiana in 2019 was estimated to be over
11	nine hundred dollars, which is difficult to cover with a maximum weekly benefit amount of
12	two hundred forty-seven dollars; and
13	WHEREAS, the COVID-19 pandemic has caused businesses and operations to either
14	lay off workers or reduce workers' hours; and
15	WHEREAS, due to layoffs and reductions in work hours, workers are now forced to
16	overcome unprecedented financial burdens and obstacles; and
17	WHEREAS, the state of Louisiana moved into Phase 2 of reopening on Friday, June
18	5, 2020; however, some businesses and operations have begun shutting down again due to
19	the rise in the number of COVID-19 diagnoses; and

1	WHEREAS, an increase in the maximum weekly benefit amount in the state's
2	unemployment compensation program will assist Louisiana unemployed workers in
3	overcoming some of the financial burdens and obstacles continuously caused by the COVID-
4	19 pandemic until they are able to find new employment or return to work on a full-time
5	basis; and
6	WHEREAS, the state of Louisiana should also expand its unemployment
7	compensation program's eligibility to include those who have historically been denied
8	unemployment compensation benefits, such as workers who are low-income, gig,
9	undocumented, or self-employed; and
10	WHEREAS, the people of Louisiana must recognize that many of these workers are
11	residents of this state and are valued contributors to the state's workforce and have also been
12	greatly affected by the COVID-19 pandemic; and
13	WHEREAS, the Federal Pandemic Unemployment Compensation (FPUC) program
14	has relieved some of the financial hardships that these workers have faced and will
15	continuously face; and
16	WHEREAS, when the FPUC program expires, a number of these workers may still
17	not be able to return to work, at all, or on a full-time basis; and
18	WHEREAS, the state needs to intervene and help alleviate some of the economic
19	strain that its residents continuously face due to the COVID-19 pandemic.
20	THEREFORE, BE IT RESOLVED that the House of Representatives of the
21	Legislature of Louisiana does hereby urge and request the House Committee on Labor and
22	Industrial Relations to meet and study the feasibility of increasing unemployment
23	compensation amounts and expanding unemployment compensation eligibility.
24	BE IT FURTHER RESOLVED that, in carrying out the purposes of this Resolution,
25	the House Committee on Labor and Industrial Relations shall engage and solicit input,
26	recommendations, and advice from all interested parties and stakeholders.
27	BE IT FURTHER RESOLVED that the committee may conduct as many meetings
28	it deems necessary or convenient to enable it to exercise its powers fully and effectively,
29	perform its duties, and accomplish the objectives and purposes of this Resolution before it
