2	To commend the members of Renegade Troop for their patriotic service.
3	WHEREAS, after the September 11, 2001, attacks, Renegade Troop left their
4	families and friends to answer the call to come forth in defense of our nation; the Renegade
5	Troop members came from all over the country to Fort Johnson in Leesville, Louisiana, to
6	prepare for engaging the enemy; the troop, comprised of eight UH-60 Lima Blackhawk
7	helicopters, trained themselves constantly under the mantra "always ready"; Renegade Troop
8	will reassemble in Lake Charles, Louisiana, in March 2024 to recognize the twentieth
9	anniversary of their tour; and
10	WHEREAS, Renegade Troop was part of 4th Squadron, 2nd Armored Cavalry
11	Regiment, which conducted combat operations for sixteen months as part of Operation Iraqi
12	Freedom; Renegade Troop deployed to Iraq from March 2003 to July 2004; and
13	WHEREAS, Renegade Troop flew from Red Catcher Army Airfield in Baghdad,
14	Iraq; Blair Army Airfield Field in Al-Kut, Iraq; and in support of the fight to defeat the
15	Madhi Army led by Moqtada Al-Sadr in An-Najaf, Iraq; and
16	WHEREAS, Renegade Troop flew air movement, internal and external loads, and
17	commanded and controlled multi-echelon combined arms operations in support of 3rd
18	Infantry Division, 1st Armored Division, and 2nd Armored Cavalry Regiment for a total of
19	over ten thousand combat flight hours; and
20	WHEREAS, Renegade Troop flew over eight thousand passengers and moved over
21	one hundred and fifty tons of cargo; and
