2	To commend Noel Hunt, director of the Office of Human Resources of the Louisiana House
3	of Representatives, upon his retirement after thirty-five years of state service and
4	thirty years as an integral member of the House staff and to recognize and record his
5	many significant contributions to the Legislature of Louisiana.
6	WHEREAS, Noel Hunt, one of the most effective and respected members of the staff
7	of the Louisiana House of Representatives, is retiring in April of 2013, and the members of
8	the House desire to record and recognize his legacy of expertise and excellence; and
9	WHEREAS, Mr. Hunt is retiring after thirty-five years of state service and thirty
10	years as a member of the House staff, during which time he has served eight different
11	Speakers of the House and the members of the House with unwavering diligence; and

1	WHEREAS, after graduating from college in 1969 and serving a tour of duty in the
2	United States Army during the Vietnam era, Mr. Hunt began his career with the East Baton
3	Rouge Parish Juvenile Court, where he served for ten years; and
4	WHEREAS, Mr. Hunt earned a master of business administration degree from
5	Southeastern Louisiana University in 1979, and he accepted a position with the Division of
6	Administration as an analyst; and
7	WHEREAS, in 1981, Mr. Hunt was hired by David R. Poynter, Executive Director
8	of House Legislative Services, as an analyst for the House Committee on Appropriations,
9	and in January of 1988, Mr. Hunt accepted a position as a lobbyist with Haynie and
10	Associates; and
11	WHEREAS, in January of 1990, Mr. Hunt returned to the House staff as Executive
12	Director of House Legislative Services (HLS), a position in which he was charged with
13	supervision and direction of the House staff responsible for research, bill drafting, and
14	committee staffing, and during Mr. Hunt's years in this critical role, he oversaw many
15	changes in HLS, including participation in a National Conference of State Legislatures
16	management study of HLS and development by the HLS management staff of an HLS
17	management plan to establish a revitalized staffing philosophy and implement current
18	management trends; and
19	WHEREAS, Mr. Hunt continued serving in this position until January of 1999, when
20	he helped to establish the House of Representatives' Office of Human Resources and was
21	named its first director; and
22	WHEREAS, Mr. Hunt has served with great effectiveness in this vital role, working
23	with the office's staff to expertly serve the members and staff of the House regarding a wide
24	variety of employment issues, including complex matters related to insurance and retirement,
25	and helping to promote a fair, safe, healthy, stable, cooperative, and productive work
26	environment; and
27	WHEREAS, Mr. Hunt carried his knowledge beyond the confines of the capitol as
28	a panelist for a program on professional and legal issues for legislative e-mail for the
29	National Conference of State Legislatures 2008 Legislative Summit; and

WHEREAS, upon his retirement, Mr. Hunt will be greatly missed by the members and staff of the Louisiana House of Representatives, who will continue to respect and admire him and value his friendship; and
WHEREAS, Mr. Hunt is an inspiration to his fellow citizens for the vital
