1	AN ACT
2	To amend and reenact R.S. 26:351(7), 493.1, 583(C)(2), 597(A), and 598(A), relative to
3	provisions of Title 26 (Liquors - Alcoholic Beverages) of the Louisiana Revised
4	Statues of 1950, which are limited in applicability to certain political subdivisions
5	or local areas based upon population classifications; to specify applicability to one
6	or more political subdivisions or local areas; to adjust population categories to retain
7	applicability; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 26:351(7), 493.1, 583(C)(2), 597(A), and 598(A) are hereby
10	amended and reenacted to read as follows:
11	§351. Limitation on size of containers of beverages of high alcoholic content;
12	standards of fill
13	Except for wines, no manufacturer or wholesaler in this state shall have in his
14	possession any beverages of high alcoholic content outside of his bonded stockroom
15	unless they are in containers of no greater capacity than 1.75 liters. The standards
16	of fill shall be the following:

18	(7) Notwithstanding the provisions of Paragraph (6) or any other law to the
19	contrary, in parishes with a population of four hundred thousand or more, and in the
20	parishes of Caddo, Bossier, Caddo, Calcasieu, East Baton Rouge, Jefferson,
21	Lafayette, Orleans, Ouachita, and Rapides, and Ouachita, regardless of population
22	and parishes with a population of not less than three hundred sixty thousand and not
23	more than four hundred ten thousand, beverages of high alcoholic content may be
24	sold in or shipped into this state in fifty milliliter containers and stored by licensed
25	wholesale dealers only for the purpose of sale to licensed retail dealers who own or
26	operate hotels or motels which consist of sleeping rooms, cottages, or cabins, for
27	purposes of sale at retail in the sleeping rooms, cottages, or cabins only. The sale of

1	fifty milliliter containers from wholesalers to retailers shall be made only in full
2	sealed case lots as delivered from the manufacturer to the wholesaler, and the cases
3	shall remain sealed until such time as the sale and delivery to the retailer are
4	completed.

6	§493.1. Local regulatory ordinances; bar closing in certain municipalities
7	In addition to the provisions of R.S. 26:493 the governing authority of any
8	municipality within a parish with a population between fifty-three thousand and
9	fifty-seven sixty thousand persons according to the most recent federal decennial
10	census may enact ordinances to regulate the closing times of bars located within the
11	municipality, subject to approval by a majority of the qualified electors of the
12	municipality voting at an election held for the purpose.
