1	AN ACT
2	To amend and reenact R.S. 56:722(A)(2) and 727, relative to game and fish commissions;
3	to provide for the adoption of rules and regulations; to provide for limitation of
4	liability; to provide for terms and conditions; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 56:722(A)(2) and 727 are hereby amended and reenacted to read as
7	follows:
8	§722. Game and fish commission; rules and regulations
9	A.(1) * * * *
10	(2) The commission may make rules and regulations for the government,
11	regulation, and control of the preserve and for the conservation, protection, and
12	propagation of game and fish in the preserve , provided that such. In order to adopt
13	such rules and regulations, the game and fish commission shall hold a public
14	hearing conducted in accordance with the Open Meetings Law where public
15	comment and testimony is received by the game and fish commission. Prior to
16	implementation, such rules and regulations shall be finally approved, adopted, and
17	promulgated by the Louisiana Wildlife and Fisheries Commission, in accordance
18	with R.S. 56:727.

20	§727. Approval of rules and regulations; promulgation; penalties
21	A. Rules and regulations proposed by any parish game and fish commission
22	shall become effective only after being approved by the only after one of the
23	following occurs:
24	(1) The Louisiana Wildlife and Fisheries Commission, which has concurrent
25	jurisdiction and power over the parish preserve, approves and promulgates the rule

1	or regulation. Such rules and regulations shall be promulgated and adopted in
2	accordance with the Administrative Procedure Act.
3	(2) If the Louisiana Wildlife and Fisheries Commission fails to take
4	action on the proposed rules and regulations within one hundred eighty days
5	after submission by the commission, the proposed rules shall be deemed to be
6	adopted. The game and fish preserve commission shall publish the adopted rule
7	or regulation in the Louisiana Register, shall submit a copy to the Senate
8	Committee on Natural Resources and the House Committee on Natural
9	Resources and Environment. The rule or regulation shall be subject to
10	legislative review in the same manner as provided in the Administrative
11	<u>Procedure Act, R.S. 49:968(D).</u>
12	<u>B.</u> Any person who violates a rule or regulation adopted as provided in this
13	Section shall be guilty of a class 2 violation.
14	C. The Louisiana Wildlife and Fisheries Commission shall not be held
15	liable with regard to any implementation, promulgation, or enforcement of any
16	rules or regulations of a game and fish commission adopted pursuant to
17	Paragraph (A)(2) of this Section or R.S. 56:722(A)(2).
