13	B. The commissioner of higher education shall be appointed by a two-thirds
14	vote of the total membership of the Board of Regents and shall be subject to

- 2 Section 2. This Act shall become effective upon signature by the governor or, if not
- 3 signed by the governor, upon expiration of the time for bills to become law without signature
- 4 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 5 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 6 effective on the day following such approval.

Appel (SB 108)

DIGEST

<u>Present law</u> provides that the Board of Regents shall appoint a commissioner of higher education to administer and implement board programs and policies. Further provides that the commissioner shall possess such qualifications and have such other powers, functions, duties, and responsibilities as established by the board or as provided by law.

<u>Proposed law</u> retains these provisions.

<u>Present law</u> provides that the commissioner of higher education shall be appointed by a twothirds vote of the total membership of the board and shall be subject to confirmation by the Senate.

<u>Present law</u> provides that the salary of the commissioner of higher education shall be determined by the board, subject to the approval of the Joint Legislative Committee on the Budget (JLCB).

<u>Proposed law</u> deletes the requirement that JLCB approve the salary of the commissioner of higher education.

Effective upon signature of the governor or lapse of time for gubernatorial action.
