Substances Law which is a felony, or any crime which is defined as a sex offense in R.S. 15:541, or any crime defined as an attempt to commit one of the aboveenumerated offenses under the laws of this state, or who has been convicted under the laws of any other state or of the United States or of any foreign government or country of a crime which, if committed in this state, would be one of the aboveenumerated crimes, to possess a firearm or carry a concealed weapon.

(2) This Section shall also apply to any person that committed a felony-grade delinquent act described in Paragraph (1) of this Subsection if adjudicated when that person was a child, as defined in Ch. C. Article 804, and such person is under age twenty-four.

SB 115 Engrossed 2021 Regular Session

Present law prohibits any person convicted of, or found not guilty by reason of insanity for, a crime of violence as defined in present law, or any crime defined as an attempt to commit a crime of violence under the laws of Louisiana, or has been convicted under the laws of any other state or of the United States or of any foreign government or country of a crime which, if committed in this state, would be a crime of violence, from possessing a firearm or carrying a concealed weapon.

Proposed law retains present law and extends the prohibition from possessing a firearm or carrying a concealed weapon to persons that committed a felony-grade delinquent act (a crime of violence committed by a child) when that person was a child and that person is under the age of 24.

Effective August 1, 2021.
