AN ACT

2	To amend and reenact R.S. 17:434(A) and to enact R.S. 17:426, relative to teachers and
3	other school employees; to provide relative to planning time and lunch periods for
4	teachers; to provide for an uninterrupted planning period for teachers; to delete
5	requirements for a duty-free lunch period for teachers; to provide for an exemption
6	from tolls on the Louisiana Highway 1 Bridge for teachers, school bus drivers, and
7	other school employees; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 17:434(A) is hereby amended and reenacted to read as follows:
10	§434. Planning time and lunch periods for teachers; required
11	A.(1) The State Board of Elementary and Secondary Education shall adopt
12	necessary rules and regulations requiring, beginning with the 2000-2001 school year
13	each city and parish school board to provide a minimum of forty-five minutes daily
14	uninterrupted planning time, or its weekly equivalent, and a minimum of thirty
15	minutes for lunch each day which shall be duty-free for every teacher actively
16	engaged in the instruction and supervision of students in the public schools
17	Implementation of planning time and lunch periods as required in this Section for
18	teachers shall not result in a lengthened school day or a reduction in student daily
19	instructional time.
20	(2) The provisions of this Subsection shall be subject to the availability of
21	state funds for this purpose.

2	Section 2. R.S. 17:426 is hereby enacted to read as follows:
3	§426. Free and unhampered passage on the Louisiana Highway 1 Bridge;
4	teachers, school bus drivers, and other school employees
5	A. Notwithstanding any other provision of law to the contrary, every
6	teacher, school bus driver, and other school employee employed by the
7	Lafourche Parish School Board shall have free and unhampered passage
8	crossing the Louisiana Highway 1 Bridge, also known as the Tomey J. Doucet
9	Bridge, when traveling to and from their work place on a scheduled work day,
10	as prescribed by the school board, not to exceed two toll-free crossings in one
11	day.
12	B. The Department of Transportation and Development shall adopt
13	rules and regulations to implement and enforce the provisions of this Section in
14	accordance with the Administrative Procedure Act.
15	Section 3. The provisions of Section 1 of this Act shall become effective on
16	July 1, 2022.
17	Section 4. The provisions of Section 2 of this Act shall become effective on
18	August 1, 2023, or upon the adoption of final rules and regulations by the
19	Department of Transportation and Development to implement the Section, whichever
20	date is sooner.
