SENATE BILL NO. 130

BY SENATOR CROWE

CRIME/PUNISHMENT. Prohibits the sale of Kratom to or the purchase or possession of Kratom by any person under 18 years of age. (gov sig)

1 AN ACT

2 To enact R.S. 14:91.9, relative to crimes involving the distribution, purchase, or possession
3 of certain substances; to create the crime of unlawful distribution, purchase, or
4 possession of Kratom; to provide for definitions; to provide for penalties; and to
5 provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 14:91.9 is hereby enacted to read as follows:

8 **§91.9. Unlawful distribution, purchase, or possession of Kratom; penalties**

9 **A. It is unlawful for any manufacturer, distributor, retailer, or other**
10 **person knowingly to distribute Kratom to any person under the age of eighteen**
11 **years.**

12 **B. It is unlawful for any person under the age of eighteen years to**
13 **purchase or possess Kratom.**

14 **C. For the purposes of this Section:**

15 **(1) "Distribute" means to sell, barter, trade, furnish, supply, provide, or**
16 **otherwise transfer to another person.**

17 **(2) "Kratom" means a tropical tree of the genus and species Mitragyna**

1 **speciosa, its leaves, or any extract, powder, capsule, or other substance derived**
2 **therefrom.**

3 **D. Whoever violates the provisions of this Section shall be fined not more**
4 **than five hundred dollars, or imprisoned for not more than six months, or both.**

5 Section 2. This Act shall become effective upon signature by the governor or, if not
6 signed by the governor, upon expiration of the time for bills to become law without signature
7 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
8 vetoed by the governor and subsequently approved by the legislature, this Act shall become
9 effective on the day following such approval.

DIGEST

Crowe (SB 130)

Proposed law makes it a crime for any manufacturer, distributor, retailer, or other person knowingly to distribute Kratom to any person under the age of 18.

Proposed law further makes it a crime for any person under the age of 18 to purchase or possess Kratom.

Proposed law provides the following definitions:

1. "Distribute" means to sell, barter, trade, furnish, supply, provide, or otherwise transfer to another person.
2. "Kratom" means a tropical tree of the genus and species *Mitragyna speciosa*, its leaves, or any extract, powder, capsule, or other substance derived therefrom.

Proposed law provides that whoever violates the provisions of proposed law is to be fined not more than \$500, or imprisoned for not more than six months, or both.

Effective upon signature of the governor or lapse of time for gubernatorial action.
