2	To enact R.S. 32:412(M) and R.S. 40:1321(M), relative to drivers' licenses and special
3	identification cards; to provide for the exhibition of the logo of any Louisiana
4	university on a driver's license and special identification card; to authorize collection
5	of a university logo fee, if any, as established by any Louisiana university for the use
6	and display of its logo; to provide for the disbursement of such logo fees collected
7	to the foundation of such universities; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 32:412(M) is hereby enacted to read as follows:
10	§412. Amount of fees; credit or refund; duration of license; veteran designation;
11	university logo; "I'm a Cajun" designation; disbursement of funds;
12	renewal by mail or electronic commerce of Class "D" or "E" drivers
13	licenses; disposition of certain fees; exception
14	* * *
15	M.(1) Upon request and payment of a university logo fee, if any, as
16	established by any Louisiana university for the use and display of its logo, the
17	logo of the university shall be exhibited in color on the driver's license
18	regardless of its class. The deputy secretary of the Department of Public Safety
19	and Corrections, public safety services, shall comply with the provisions of this
20	Subsection.
21	(2) The department shall collect such university logo fee, if any, which
22	shall be disbursed in accordance with Paragraph (3) of this Subsection. This
23	university logo fee shall be in addition to the payment of any other driver's
24	license fee.

1	(3) Any monies received from such university logo fees shall be disbursed
2	quarterly by the department to the foundation of the university.
3	(4) The deputy secretary of the Department of Public Safety and
4	Corrections, public safety services, shall establish such rules and regulations as

6	(5) Any implementation costs shall be incurred by the foundation of the
7	university participating in the university logo program.
8	Section 2. R.S. 40:1321(M) is hereby enacted to read as follows:
9	§1321. Special identification cards; issuance; veteran designation; university logo;
10	"I'm a Cajun" designation; fees; expiration and renewal; exceptions;
11	promulgation of rules; promotion of use; persons less than twenty-
12	one years of age; the Protect and Save our Children Program;
13	Selective Service Registration
14	* * *
15	M.(1) Upon request and payment of a university logo fee, if any, as
16	established by a Louisiana university for the use and display of its logo, the logo
17	of the university shall be exhibited in color on the special identification card.
18	The deputy secretary of the Department of Public Safety and Corrections,
19	public safety services, shall comply with the provisions of this Subsection.
20	(2) The department shall collect such university logo fee, if any, which
21	shall be disbursed in accordance with Paragraph (3) of this Subsection. This
22	university logo fee shall be in addition to the payment of any other special
23	identification card fee.
24	(3) Any monies received from such university logo fee shall be disbursed
25	quarterly by the department to the foundation of the university.
26	(4) The deputy secretary of the Department of Public Safety and
27	Corrections, public safety services, shall establish such rules and regulations as
28	are necessary to implement the provisions of this Subsection.
29	(5) Any implementation costs shall be incurred by the foundation of the
